Sub: Diversion of 0.7682 ha of forest land for construction of 400 KV D/C Rajarhat-Purnea Transmission Line in Purnea & Bhagalpur Forest Division of Bihar by PGCIL.

Sir,

I am directed to refer to letter No.Van Bhumi-35/2016-812(E)/Pa.Va. dated 7.12.2016 of the State Government & letter No.FC-471 dated 21.6.2017 of Nodal Officer on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest and Climate Change under section 2 of Forest (Conservation) Act, 1980.

After due consideration of the proposal of the State Government, the Central Government, hereby, conveys "in-principle" approval for diversion of 0.7682 ha of forest land for construction of 400 KV D/C Rajarhat-Purnea Transmission Line in Purnea & Bhagalpur Forest Division of Bihar by PGCIL, subject to the fulfillment of the following conditions.

- 1. Legal status of forest land proposed for diversion shall remain unchanged.
- 2. The State Govt. shall charge the Net Present Value (NPV) of forest area proposed to be diverted under this proposal from the user agency as per the Orders of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 05.02.2009 in this regard.
- 3. Additional amount of NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India, shall be charged by the State Govt. from the user agency.
- 4. The State Government shall plant 3500 trees as compensatory afforestation to maintain the green cover at the project cost. Planting site for the purpose shall

be identified by the State Forest Department preferably within or in the surrounding area of the project. Indigenous tree species should be preferred for such plantation. The user agency shall transfer the cost of plantation and its maintenance for 7 years (revised as on the date to incorporate the existing wage structure) to State Forest Department.

- 5. The State Government shall plant 3500 trees as penal compensatory afforestation to maintain the green cover at the project cost. Planting site for the purpose shall be identified by the State Forest Department preferably within or in the surrounding area of the project. Indigenous tree species should be preferred for such plantation. The user agency shall transfer the cost of plantation and its maintenance for 7 years (revised as on the date to incorporate the existing wage structure) to State Forest Department
- 6. The State Government shall deposit Net Present Value and all other funds through e-challan, with the Ad-hoc Body of Compensatory Afforestation Fund Management and Planning Authority (CAMPA), in SB Account No.SB01025201 of Corporation Bank, CGO Complex, Phase-1, Lodhi Road, New Delhi 110 003 (RTGS/IFSC No.CORP0000371) through the RTGS/NEFT mode, as per the instructions communicated vide letter No.12-2/2010-CAMPA dated 13.05.2011 and dated 24.06.2011.
- 7. State Government shall upload the details of compensatory levies demanded and received from the project proponent on the Ministry website and submit compliance in this regard.
- 8. Transmission lines should be aligned in such a way that it involves the least amount of tree cutting. Felling of trees on the forest land being diverted shall be restricted to the bare minimum and the trees should be felled under strict supervision of the State Forest Department.
- 9. The boundary of the forest land proposed for diversion, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, DGPS coordinates, forward and back bearing and distance from adjoining pillars etc.
- 10. No labour camp shall be established on the forest land.
- 11. The User Agency shall provide alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas for collection of firewood for their use.

- 12. It will be the responsibility of the User Agency to ensure that the labourers, staff engaged in construction activity do not damage the nearby forest flora and fauna.
- 13. Width of Right of Way for the Transmission Line shall be limited to 46 m.

- 14. The User Agency shall install circuit breakers at suitable places besides maintaining necessary ground clearance to prevent electrocution of wild animals like elephant.
- 15. To minimize the felling for construction of Transmission Line, User Agency shall comply with the following guidelines:
  - a) Below each conductor, width clearance of 3 mts would be permitted for stringing purpose. The trees on such strips may be felled but after stringing work is completed, the natural regeneration will be allowed to come up.
  - b) Outer strip may be left clear to permit maintenance of the Transmission Line.
  - c) In the remaining width of Right of Way felling/ pollarding/ pruning of trees will be done with the permission of the local Forest Officer whenever necessary to maintain the electrical clearance. Trees shall be allowed to be felled or lopped to the extent required, for preventing electrical hazards by maintaining the minimum 5.5 meter clearance between conductors and trees. The sag and swing of the conductors are to be kept in view while working out the minimum clearance mentioned as above.
  - d) The Scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in Right of Way under the Transmission Line, as prepared by the State Forest Department shall be implemented from the funds provided by the User Agency.
  - e) In case a portion of the Transmission Line to be constructed is located in hilly areas, where adequate clearance is already available, trees shall not be felled.
- 16. The lay out plan of the proposed forest land shall not be changed without prior approval of the Ministry of Environment, Forests and Climate Change.
- 17. The forest land proposed for diversion shall under no circumstances be transferred to any other agency, department or person without prior approval of the Ministry of Environment, Forest and Climate Change.
- 18. The forest land shall not be used for any purpose other than that specified in the proposal.

- 19. The user agency and the State Government shall ensure compliance of provisions of all the Acts, Rules, Regulations and Guidelines, for the time being in force, which are applicable to the project.
- 20. Any other condition that the Ministry of Environment, Forests and Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency.

After receipt of the compliance report on fulfillment of the conditions as stipulated above, from the State Government, formal approval will be issued in this regard under Section 2 of Forest (Conservation) Act, 1980. Transfer of forest land to user agency should not be effected by the State Government till formal order approving diversion of forest land is issued by the Central Government.
