**विषय: Diversion of 10.299 ha. of forest land in favor of Power Grid Corporation India Limited, Falodi, Jodhpur for construction of 765 KV D/C Bhadla to Bikaner transmission line.**

सन्दर्भ: शासन सचिव (वन), राजस्थान शासन, जयपुर का पत्रांक-प.1(20)वन/2019, दिनांक-01.07.2019.

महोदय,

उपरोक्त विषय पर शासन सचिव, वन विभाग, राजस्थान शासन का पत्रांक-प01(20)वन/2019, दिनांक-07.06.2019 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रस्ताव पर वन (संरक्षण) अधिनियम, 1980 की धारा (2) के अन्तर्गत भारत सरकार की स्वीकृति माँगी गयी थी।

प्रकरण को दिनांक-02.07.2019 को आहूत की गयी क्षेत्रीय सशक्त समिति (REC) की बैठक में (REC Agenda item 39.4-RAJ) शामिल किया गया था, बैठक में प्रकरण को स्वीकृति प्रदान की गयी है। क्षेत्रीय सशक्त समिति की स्वीकृति उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि केन्द्र सरकार उपरोक्त विषयांकित परियोजना हेतु 10.299 हे० वन भूमि के प्रत्यावर्तन एवं 589 वृक्षों के पातन की सैद्धान्तिक स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है:-

- 1- Legal status of the forest land shall remain unchanged.
- 2- Compensatory afforestation shall be taken up by the Forest Department over 20.598 ha degraded forest land (Compartment No. 79/80, Nil, Village-Chakk6 JWM, Osian, Siyasar Tehsil-Nachana, Pugal, Jodhpur, District-Jodhpur, Jaisalmer, Bikaner) at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
- 3- The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme for plantation 1000 plants/ha. as per FCA guidelines and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- 4- The State Government shall charge the Net Present Value (NPV) for the 10.299 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard.
- 5- Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.




- 6- User agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- 7- All the funds received from the user agency under the project shall be transferred/ deposited to CAMPA fund only through e-portal.
- 8- The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 9- **The User agency in consultation with the State Forest Department prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of way under the transmission line and deposit the cost for execution of the said scheme to the State Forest Department.**
- 10- **The user agency at its cost shall provide bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.**
- 11- **The User Agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter no. 7-25/2012-FC dated 05/05/2014.**
- 12- User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
- 13- The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 14- **No labour camp shall be established on the forest land.**
- 15- Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 16- The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 17- No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 18- The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
- 19- If Muck disposal is proposed on private land then, consent letter/NOC of private land owner has to be provided.
- 20- Certificate of Minimum use of Forest land, justification for locating the project in forest area etc. are not countersigned by concerned DFO. All the concerned certificates, countersigned by concerned DFO's have to be provided in original.
- 21- All the certificates of DFO, IGNP Stage II, Bikaner have to be provided in original
- 22- The forest land shall not be used for any purpose other than that specified in the project proposal.
- 23- The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- 24- Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
- 25- Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
- 26- The compliance report shall be uploaded on e-portal (<https://parivesh.nic.in/>).
