

शासन सचिव(वन) राजस्थान शासन सिविल सचिवालय जयपुर (राजस्थान)

विषयः 400 के0वी0 डी0/सी0 आगरा भिवाड़ी विद्युत लाईन हेतु अलवर में 7.436 हे0 वन भूमि का प्रत्यावर्तन। सन्दर्भः शासन सचिव(वन), जयपुर, राजस्थान का पत्रांक-प0 1(86)वन/2008 पार्ट, जयपुर, दिनांक-14.09.2020.

महोदय,

उपरोक्त विषयक शासन सचिव, वन विभाग, राजस्थान शासन के पत्रांक प.1(86)वन/2008, दिनांक 16.06.2008 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रस्ताव पर वन (संरक्षण) अधिनियम, 1980 की धारा (2) के अन्तर्गत भारत सरकार की स्वीकृति मॉगी गयी थी।

प्रस्ताव के सम्बन्ध में उक्त संदर्भित पत्र द्वारा प्रस्तुत अनुपालना पर विचारोपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि केन्द्र सरकार विषयांकित प्रकरण हेतु 7.436 हे० संरक्षित वनभूमि के प्रत्यावर्तन एवं शून्य वृक्षों के पातन की विधिवत स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है:—

- 1. Legal status of the forest land shall remain unchanged.
- 2. Forest land will be handed over only after required non-forest and for the project is handed over to the user agency.
- 3. Compensatory afforestation shall be taken up by the Forest Department over an area of 7.436 ha or 7.44 ha. equivalent non-forest land (Khasara No.664, Village Milakpurturk, Tehsil Tizara, District Alwar) at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
- 4. The non-forest land which has been transferred and mutated in favour of the State Forest Department for the purpose of compensatory afforestation shall be declared as Reserved Forest under Section-4/20 or Protected Forest under Section-29 of the Indian Forest Act, 1927 or under the relevant Section(s) of the State Forest Act. The Nodal Officer, Forest (Conservation) Act, 1980 may report compliance within a period of six (6) months from the date of grant of final approval and send a copy of the original notification declaring the non-forest land under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the State Forest Act as the case may be, to this Office for information and record.
- 5. Plantation of dwarf species (preferably medicinal plants) in ROW under transmission line shall be taken up by forest department at the cost of User agency.
- 6. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- 7. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.

- 8. The user agency at its cost shall provide bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.
- 9. The User Agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter no. 7-25/2012-FC dated 05/05/2014 & 19/11/2014.
- 10. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
- 11. The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 12. No labour camp shall be established on the forest land.
- 13. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 14. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 15. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 16. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
- 17. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 18. The User Agency and the State Government shall ensure compliance of all the Court orders, provisions, rules, regulations and guidelines for the time being in force as applicable to the project.
- 19. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- 20. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
- 21. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
