Subject:Diversion of 24.204 ha of FL in Kadapa (18.377ha) & Anantapur (5.827 ha) divisions for construction of 400 KV Double Circuit Kadapa-Hindupur Power Transmission line in favour of Power Grid Corporation of India Ltd-reg

Sir,

Please refer to the State Government's letter No. 5617/Section-II/2016 dated 15.12.2016 and online proposal No. FP/AP/TRANS/14620/2015 seeking prior approval of the Government of India in accordance with Section'2' of Forest (Conservation) Act, 1980 for the above mentioned project. The project was accorded in-principle approval (Stage-I) by the Central Government vide letter dated 17.02.2017. The State Government vide letter Nos. 5617/Section-II/2016 dated 07.02.2020 and 08.12.2020 have reported compliance to the conditions stipulated in the in-principle approval.

After careful consideration of the proposal of the State Government, I am to convey the Central Government's approval (*Stage-II*) under Section '2' of Forest (Conservation) Act, 1980 for diversion of 24.204 ha of FL in Kadapa (18.377ha) & Anantapur (5.827 ha) divisions for construction of 400 KV Double Circuit Kadapa-Hindupur Power Transmission line in favour of Power Grid Corporation of India Ltd, subject to the following conditions:-

- Legal status of the diverted forest land shall remain unchanged;
- The boundary of the diverted forest land shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates

- The State Forest Department shall carry out Compensatory Afforestation (CA) over 51.81 ha of degraded forest in Compt No. 693 of Palakonda and Vongimalla RF in Rayachoty Range of Kadapa Division from the amount which has already realized from the User Agency;
- iv) Identified CA land and approved CA scheme shall not be changed without the prior approval of the Central Government;
- V) Additional amount of Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the User Agency;
- vi) The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- vii) Minimal disturbance should be ensured by creating labour camps outside the forest area as far as possible and it will be the responsibility of the user agency to ensure that the labourers & staff engaged in execution of work do not destruct nearby forest flora & fauna;
- viii) State Forest Department shall raise and maintain sufficient numbers of red sanders saplings in the proposed CA land as proposed by the DFO, Kadapa Division;
- ix) The State Forest Department shall translocate the trees, wherever feasible instead of felling at the cost of user agency;
- X) The State Forest Department shall carry out plantation of dwarf species preferably medicinal plants in the Right of Way under the transmission line from the amount which has already been realized from the User Agency;
- xi) The User Agency shall bear the cost every year for special protection of the forest blocks through which the line is passing, as per the assessment of DFOs, Kadapa and Ananthapur Divisions;
- xii) The forest land proposed for diversion shall under no circumstances be transferred or subleased to any other agency, department or person without prior approval of the Central Government;
- xiii) The total forest area utilized for the project shall not exceed 24.204 ha and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal;
- XIV) The user agency at its cost shall provide bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.
- xv) The User Agency shall comply with the guidelines for laying transmission lines

through forest areas issued by Ministry vide letter no. 7-25/2012-FC dated 05/05/2014 & 19/11/2014.

- XVI) No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- XVII) The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
- XVIII) Any other conditions that the Central Government or Regional Officer (Central) of Integrated Regional Office, Vijayawada may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency;
- XiX) The Progress of the Compensatory Afforestation as mentioned by the DFOs part II of the proposals shall be monitored by the Circle Head and a copy of such monitoring report shall be forwarded to the Integrated Regional Office to upload the same in the web portal;
- XX) The user agency and the State Govt. shall ensure compliance of all the court orders, provisions, rules, regulations and guidelines for the time being in force, as applicable to the project.
- In the event of failure to comply with any of the above conditions the user agency is liable for penal action per the provisions made in rules / guidelines framed under, FCA, 1980.
