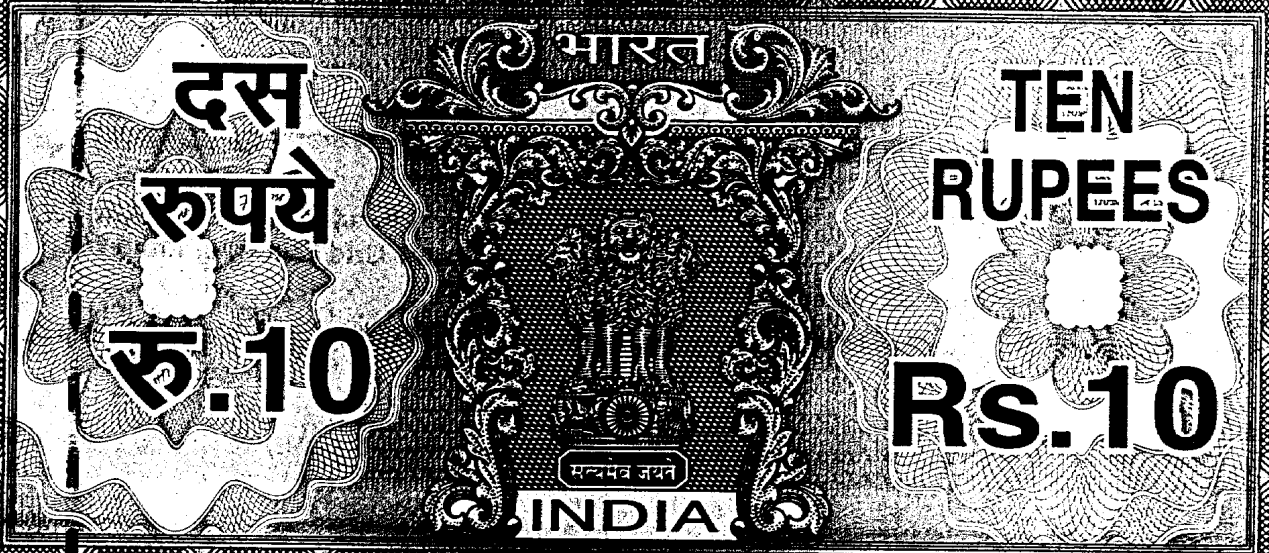

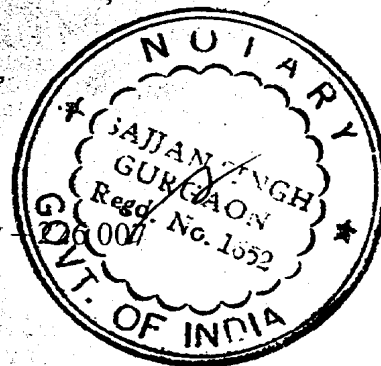

Affidavit verifying the Petition


