4. **Power of attorney , if applicable.** (on stamp paper)
5. **MLC/MII** : Minimum local content : on 100/- stamp paper (format attached)
6. **QR** (Qualifying Requirements):
  - I. **Technical experience: Work Orders with completion certificates** as mentioned in QR.
  - II. **Financial requirement:** Balance sheet and Profit & Loss statement for the last Five years or as mentioned in QR.
7. **General Documents:**
  - i. Copy of PAN Card.
  - ii. Copy of GSTIN.
  - iii. Copy of Partnership Deed/ Affidavit for Proprietorship/ Company MoA & AoA or Certificate of Incorporation, as applicable.
