The Contractor shall submit a Contract Performance Guarantee (CPG)/ePBG in the amount equivalent to Ten percent (10%) of the Contract Price, with validity up to Ninety (90) days beyond the warranty period. If the manufacturer fails to submit the same then the security amount (equivalent to ePBG) shall be kept on hold from the bills.

The Contract Performance Guarantee (CPG)/ePBG shall be released only after the successful completion of the warranty period.
