1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Quantity Variation: The buyer can increase or decrease the contract quantity or contract duration u p to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or cont ract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

Liquidated damages (LD): If party fail to provide the requisite vehicle(s) according to the requirement of th e Corporation either partially or fully on any day (unauthorize d absence) an amount equal to Three times of the rate per day shall be deducted from the monthly bills for any unauthorized absence. Other penalties will be as per provisions in SLA & GTC

Contract Period: Initially contract period shall be for one year with 01-year extension provisions with same rate, terms & conditions.

<u>Guidelines for Hiring of Vehicles "CARAVAN" in POWERGRID through open competitive Bidding</u> / Open tender Invitation:

1. Only Commercial registered "CARAVAN" Vehicle shall be hired for use in POWERGRID.

2. Ceiling limit for hiring of "CARAVAN" Vehicle shall be 250 KM per day.

3. Payment for Extra Kilo Meter beyond specified limit in the package i.e. 250 KM per day shal I be reimbursed @ Rs. 85 /km.

4. "CARAVAN" Vehicle shall be hired for a period of 365 days.

5. The Night Hault/Emergency Duty Charges shall NOT be paid in case of outstation / Emergen cy Duty being required type of service OUT STATION 24X7.

6. Reference point for applicability of entry tax, toll tax, will be the place of consignee address identified in the bid/contract i.e. Toll tax, entry tax undertaken by agency to reach the address of consignee will not be payable.

7. Agency will quote for daily package inclusive of all charges (Driver and Helper Wages/Salary - as per min imum wages notified by CLC / State (whichever is higher) for Skilled Category and Class of City), Fuel Char ges up to 250 kM per day, Maintenance and upkeep & compliance of Statutory liability) except toll tax, par king fee, entry taxes payable locally or outstation as per SLA.

8. The "CARAVAN" vehicle should have all the good quality amenities as per TS.

9. Technically qualified bidders is to provide/facilitate inspection of "CARAVAN" vehicle includi ng all amenities as per TS through physical/online mode.

10. Agency shall be required to submit CPGs/Security deposit within 15 days of Award.

11. Agency will be responsible for compliances of all statutory requirement and no separate charges again st the same shall be passed/reimbursed by POWERGRID.

11. Local agency will be given preference and in case two or more agency becomes L1, the agency who ha ve registered office near to consignee will be considered for award.

12. In case of dishonoring the offer by agency/non-acceptance of LOA or termination of contra ct due to default, the concerned agency shall not be allowed to participate in future tenders of POWERGRID for 1 year from the date of incidence.

Station for Vehicles - At POWERGRID JAIPUR OFFICE (RAJASTHAN).

Duration of the service contract may be extended up to 12 months beyond the initial contract duration (subject to satisfactory performance and mutual consent) with same rate, terms & co nditions.

Bank Guarantee towards performance security in the amount equivalent to Five percent (05%) of the contr act price, with a validity upto ninety (90) days beyond the contract Period shall be submitted within 15 day s of the issuance of GEM Contract. The same shall be extended by the Supplier time to time till ninety (90) days beyond the actual completion Period, as may be required under the Contract. The original CPG(s) shal I be released by the POWERGRID after three months completion of contract period.

Alternatively, 5% amount shall be deducted as security from each RA bill till the amount dedu cted becomes equal to 5% of contract price. The amount deducted as security shall be returne d three months after successful completion of contract period.

Qualification of the Bidder will be based on the meeting the minimum pass/ fail criteria specified below reg arding the Bidder's technical experience and financial position as demonstrated by the Bidder's responses i n the corresponding Bid Schedules.

Technical experience and financial resources of any proposed subcontractor shall not be considered in det ermining the Bidder's compliance with the qualifying criteria. The bid can be submitted by any individual fi

rm meeting the Qualifying requirement (QR).

The Employer may assess the capacity and capability of the bidder, to ascertain that the bidder can succes sfully execute the scope of work covered under the package within stipulated completion period. This asse ssment shall inter-alia include (i) document verification; (ii) details of works executed, works in hand, antici pated in future & the balance capacity available for the present scope of work; (iii) manpower and financial resources; (iv) past experience and performance; (v) customer feedback; (vi) banker's feedback etc.

1.0 Technical Experience

1.1. The bidder/ agency should own at least 02 nos. Caravan as per Bid Specifications,

The Caravan owned by Bidder/ access to agency must be registered as commercial vehicle und er Motor Vehicle Acts and shall have valid Insurance Policy for Caravan.

1.2 In addition of para 1.1 mentioned above, bidder shall furnish an undertaking along with th e bid mentioning that before deployment of Caravan bidder shall take / arrange all necessary permissions / licenses / clearance / registrations / insurances / NOC's (as applicable) from the concerned authorities for smooth running of Caravans (as per attached Annexure-B)

In case bidder is a holding company, the technical experience referred to in clause 1.1 above shall be of th at holding company only (i.e. excluding its subsidiary/group companies). In case bidder is a subsidiary of a holding company, the technical experience referred to in clause 1.1 above shall be of that subsidiary comp any only (i.e. excluding its holding companies).

1.2 Financial Position

For the purpose of this particular bid, bidders shall meet the following minimum criteria:

a) Minimum Average Annual Turnover* (MAAT) of the bidder for best three years i.e. 36 month s out of last five financial years of the bidder as annualized should be Rs 18[#] lakhs.

* Note- "Annual gross revenue from operations/gross operating income as incorporated in the profit & loss account excluding other operative income/ other income".

In case bidder is a holding company, the financial position criteria referred to in clause 1.2 above shall be o f that holding company only (i.e. excluding its subsidiary/ group companies).

In case bidder is a subsidiary of a holding company, the financial position criteria referred to in clause 1.2 a bove shall be of that subsidiary company only (i.e. excluding its holding company).

The bidder shall also furnish following documents/details with its Bid:

a. The complete annual reports together with Audited statement of accounts of the company for last five y ears of its own (separate) immediately preceding the date of submission of the 'Bid'.

b. In case of bidder's inability to furnish the information as (a) above due to no requirement to get its Finan cial Statement Audited, the bidder shall submit Sales/submit/Turnover figures (excluding taxes) duly certified by a practicing Chartered Accountant/Cost Accountant with UDIN or Income Tax Return.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
