1. Buyer Added text based ATC clauses

1. **Experience Criteria:** Documents in support of technical Qualification requirements attached at Projec t Experience and Qualifying Criteria Requirement to be uploaded by the bidder on portal.

2. **Bidder Turnover:** Documents supporting the Financial Qualification requirements attached at Project Experience and Qualifying Criteria Requirement to be uploaded by the bidder on portal. The complete ann ual reports together with Audited statement of accounts of the company for last five years of its own (sep arate) immediately preceding the date of submission of bid to be uploaded.

3. **Certificate:** Bid Forms and Attachments (1st Envelope) attached at "Any other Documents As per Spe cific Requirement of Buyer -1" need to be filled and uploaded on GeM portal only. Soft copy of the same is attached at Buyer Added Bid Specific ATC document to facilitate bidders.

In case of non-submission of bid in the portal (soft copy part of the bid) within the stipulated deadline, then even if the bidder has submitted the specific documents in hard copy part in o riginal within the stipulated deadline pursuant to ITB 17.1, its bid shall be considered as inco mplete bid, which shall be summarily rejected.

4. Additional Doc 1: Documents requested at ITB 15.4 shall be scanned & uploaded on the portal.

5. Additional Doc 2: Power of Attorney, Integrity Pact, Safety Pact, Bid Security, Attachement-20, Attach ment-21, Attachment-22 & Attachment-23 need to uploaded on portal and Original hard copy of same to be submitted to the address: DGM [CS], Power Grid Corporation of India Ltd., East ern Region Telecom Co ntrol Center, 1st Floor, CF-17, Action Area-1C, New Town, Rajarhat, Kolkata-700156.

6. Additional Doc 3 & 4: Any other documents by bidders

7. Bidders are requested to quote their lumpsum offer (incl. all taxes) against the custom bid in the financi al portion of the bid and the detailed price break- up against the uploaded BOQ (excel file uploaded) must be uploaded by bidders in the financial portion of the bid only. However, in case price break- up is not sub mitted by any bidder in the financial portion of the bid, same shall be requested from the L1 bidder only b efore placement of the award.

Bidders uploading the duly filled BOQ/Price in the technical bid shall be rejected and no furth er clarification shall be sought. 8. Quantity variation of (+/-) 25% of the original award Value where the quantity of individual items may v ary up to any extent as per site requirements.

9. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the scr eenshot of GST portal confirming payment of GST.

10. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only

11. The Technical Specifications attached at Scope of Work, Service Level Agreement (SLA) an d Penalties has been revised and the revised Technical Specifications is attached at Buyer upl oaded ATC document.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
