Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 2. 1. Eligibility conditions: Bidders should have valid NLD or Unified License for NLD Services issued from Department of Telecommunication (DOT), Govt of India.
2. Last Mile at NNI & Customer End should Invariably be on **OFC/Fiber only**.
3. Delivery on RF is not permitted at any of the ends.
4. Delivery Period: 1 Week from date of issuance of LOI/LOA/GeM Contract whichever is earlier.
5. Liquidated Damages shall be as per GeM.
6. Termination Clause: One Month advance Notice
7. SLA Conditions shall be as per GeM.
8. End A Handover port: Optical/Mutually agreed basis at NNI.
9. End B Handover Port: RJ45 copper interface.
10. During contract period, replacement of faulty hardware due to any reason is in scope of bidder

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
