4. Following instructions to be followed while filling Price_Schedule:

b) Rate (in Rs. per Km per year per pair) must be filled same as per Dark Fiber leasing Agreement with POWERGRID/POWERTEL. The awarded rate per pair per km per annum for fiber leasing shall be considered for entire Contract/PO duration

Sellers/ Service Providers claiming to be an MSE have to register on Udyam Registration portal and provide a copy of Udyam Registration certificate, as documentary evidence in its bid in line with notification of Government of India, Ministry of Small Scale Industries, vide S.O. 1702(E) dated 1 st June, 2020 superseded by S.O. 2119(E) dated 26/06/2020 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii). In case of non-submission of the above mentioned supporting documents, the Seller/ Service Provider shall not be considered as MSE.

Assignment Clause: Notwithstanding anything to the contrary contained in this tender/agreement, POWERGRID may assign, novate or transfer its rights and obligations under this tender/Agreement to its 100% wholly owned subsidiary, namely POWERGRID TELESERVICES LIMITED.
