Sellers/ Service Providers claiming to be an MSE have to register on Udyam Registration portal and provide a copy of Udyam Registration certificate, as documentary evidence in its bid in line with notification of Government of India, Ministry of Small Scale Industries, vide S.O. 1702(E) dated 1 st June, 2020 superseded by S.O. 2119(E) dated 26/06/2020 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii). In case of non-submission of the above mentioned supporting documents, the Seller/ Service Provider shall not be considered as MSE.

Further, all other identifiers for classifying a firm as MSE viz. registration with District Industries Centers (DICs)/ Khadi & Village Industries Commission (KVIC)/ Khadi & Industries Board (KVIB)/ Coir Board or National Small Industries Corporation (NSIC)/ Directorate of Handicrafts and Handlooms/ Udyog Aadhar Memorandum etc. may not be accepted for classification as MSE".

13. Assignment Clause:

Notwithstanding anything to the contrary contained in this tender/agreement, POWERGRID may assign, novate or transfer its rights and obligations under this tender/Agreement to its 100% wholly owned subsidiary, namely POWERGRID TELESERVICES LIMITED.

POWERGRID is in the process of transferring its telecommunication business to POWERGRID TELESERVICES LIMITED as a going concern with effect from October 01, 2023 (or such other date as may be communicated by POWERGRID). Upon consummation of the said transaction, this Agreement shall stand automatically assigned by POWERGRID to POWERGRID TELESERVICES LIMITED without any further act or deed of the parties hereto, and, accordingly, on and from such date all rights and obligations of POWERGRID shall be exercised and discharged, as the case may be, by POWERGRID TELESERVICES LIMITED.
