Sellers/ Service Providers claiming to be an MSE have to register on Udyam Registration portal and provide a copy of Udyam Registration certificate, as documentary evidence in its bid in line with notification of Gov ernment of India, Ministry of Small Scale Industries, vide S.O. 1702(E) dated 1 st June, 2020 superseded by S.O. 2119(E) dated 26/06/2020 published in the Gazette of India, Extraordinary, Part II, Section3, Sub-section(ii). If a bidder is MSE (based on the documents submitted in the bid) but has not claimed

13. Assignment Clause:

Notwithstanding anything to the contrary contained in this tender/agreement, POWE RGRID may assign, novate or transfer its rights and obligations under this tender/Agr eement to its 100% wholly owned subsidiary, namely POWERGRID TELESERVICES LIM ITED.

POWERGRID is in the process of transferring its telecommunication business to POWE RGRID TELESERVICES LIMITED as a going concern with effect from October 01, 2023 (or such other date as may be communicated by POWERGRID).
