- 3. **Bidders are requested to quote their Total price (Including GST) in the P bid on GeM portal**. All other terms and conditions as per existing Dark Fiber leas greement with POWERGRID/ POWERTEL shall remain unchanged for subject lease even in the event of expiry of Dark fiber leasing Agreement during the currency of ontract.

5. During execution, POWERGRID shall check the length of fiber using OTDR and cal e the total price as below:

All payments to be made directly to the Contractor shall be made by the Employer gh electronic payment mechanism (e-payment) for which necessary details shall b tied up during execution of the Contract. However, a request for payment to be re d through RTGS shall be considered on case-to-case basis and merit of the same.

b) Bill Tracking System

Prior to submission of bills in physical form, the Contractor shall submit its bills usi OWERGRID's Vendor Bill Tracking System as per procedure detailed herein below. er, the Contractor may also track the status of its bills using POWERGRID's 'On-line dor Bill Tracking System'. - ii) After login as at (a) above, Contractor is required to make the entry WERGRID's ERP Portal under the tab "Submit New Invoice" and shall fi details along with the MSE status. Upon submission, a 16 digit unique umber will be generated and the Contractor will receive an automated il forwarding the unique BTS number.
- iii) The physical bills alongwith printed copy of e-mail received from BTS que BTS number) shall be submitted by the Contractor.
- iv) On receipt of physical bill, concerned POWERTEL's official shall online nowledge the receipt of bill. This action will trigger an automated mail e Contractor intimating that the physical copy of the bill has been rece and is under verification / processing.
