3.2 The scope of work covered under this package shall include "Replacement of floor finish with fitting and fixing vitrified/ceramic tiles and other fittings as per BOQ in Residential quarters and HRD Hostel of 400/220kV Substation, Raipur" " as detailed in the Bidding Documents:

The above scope of work is indicative and the detailed scope of work is given in the Technical Specification (Volume-II) of the Bidding documents.

- 3.3 The Completion period for "Replacement of floor finish with fitting and fixing vitrified/ceramic tiles and other fittings as per BOQ in Residential quarters and HRD Hostel of 400/220kV Substation, Raipur" shall be the period as specified in ITB Sub-Clause 24.1(c).
- 3.4 Bidding will be conducted through the domestic competitive bidding procedures as per the provisions of ITB/BDS and the contract shall be executed as per the provisions of the Contract. Bidders may note that the Purchaser has uploaded its 'Works and Procurement Policy and Procedures' (WPPP) document along with its Updation/Modification/Amendment on "Ineligibility of Firms for Participation in the Bidding Process" and on "Black-Listing of Firms / Banning of Business" and its updation on POWERGRID's website referred to at para 6.0 below. It shall be noted that no other party, including the Bidder/Supplier, shall derive any right from this 'Works and Procurement Policy and Procedures' (WPPP) document or have any claim on the Purchaser on the basis of the same. The respective rights of the Purchaser and the

Bidder/Supplier shall be governed by the Bidding Documents/Contract signed between the Purchaser and the Supplier for the respective packages. The provisions of the Bidding Documents shall always prevail over that of 'Works and Procurement Policy and Procedures' (WPPP) document in case of contradiction.

- 4.0 The detailed Qualifying Requirements (QR) are given in the Bidding Document.
- 5.0 In order to participate, the Bidder should have class-III, 2048 Bits Digital Signature Certificate.
- The complete Bidding Documents are available at POWERGRID's website http://www.powergridindia.com as well as on portal https://etender.powergrid.in. Interested bidders can download the Bidding Documents from any of the website and commence preparation of bids to gain time, however in case of discrepancy in the document; the same downloaded from latter shall prevail.
- 7.0 Important Instruction for participation in subject e-Tendering:
 - a) Bidders are requested to read the 'SRM-Bidders Manual and Pre-Requisite Document' available on e-Tender web link https://etender.powergrid.in before proceeding for submission of bids. It is important to note that bidders can submit their bids online only through https://etender.powergrid.in.
 - b) The bidding documents are meant for the exclusive purpose of bidding against this specification and shall not be transferred to any parts or reproduced or used otherwise for any purpose other than for which they are specifically uploaded.
 - c) Bidders shall ensure that their bids complete in all respects are submitted online through POWERGRID's e-tendering portal only. **No DEVIATION** in this regard is acceptable. [Refer para 8.1 below]

For proper uploading of the bids on the portal namely https://etender.powergrid.in (hereinafter referred to as the 'portal'), it shall be the sole responsibility of the bidders to apprise themselves adequately regarding all the relevant procedures and provisions as detailed at the portal as well as by contacting from POWERGRID, as and when required, for which contact details are mentioned above. The Employer in no case shall be responsible for any issues related to timely or properly

uploading/submission of the bid in accordance with the relevant provisions of Section II – ITB of the Bidding Documents.

8.0 Bidders can download the bid document from the portal without registering or paying document fees in advance, any time from **As per Rfx** however interested bidders have to pay document fees **unless otherwise exempted** for participating in the tendering and submitting the bid. For this purpose the interested bidders shall be required to pay **INR 2500/-** as non refundable document fees in the form of demand draft in favour of Power Grid Corporation of India ltd., payable at Nagpur **or** furnish the details of exemption from payment of document fees including applicable documentary proof on all working days during office hours upto **As per Rfx.** On receipt of the payment /intimation of acceptable reason for exemption by Power Grid Corporation of India Ltd., the necessary link on the portal shall be enabled by Power Grid Corporation of India Ltd., so as to make the bidders eligible to participate in the tendering and submit the bid online through the portal.

The Bidding Documents are meant for the exclusive purpose of bidding against this specification and shall not be transferred to any other party or reproduced or used otherwise for any purpose other than for which they are specifically issued.

Micro and Small Enterprises (MSEs) registered with Udyam Registration Portal as specified by Ministry of Micro, Small and Medium Enterprises are exempted from submission of fee towards the cost of Bidding Documents as per the Provisions of the Public Procurement Policy for Micro and Small Enterprises (MSEs) order 2012. Important:

with the 'Hard copy part of the Bid' in different envelope with clear marking as indicated below:

Duly signed print out of the entire First Envelope Bid uploaded on the portal https://etender.powergrid.in [Bid Form & various attachments (attachment 1 to 12)].

Envelop-5: 2nd Envelope Bids Printouts (Price)

Duly signed print out of the entire Price Bid filled against the line items online on the portal https://etender.powergrid.in along with Bid Price Summary shall be submitted in this Envelop.

NOTE:

Only Integrity Pact, Bid Security, Power of Attorney, which are part of hard copy part of the bid shall be opened and the remaining hard copy part of bids [i.e., Envelop 4 and Envelop 5, as said above] shall be kept unopened.

The Employer shall not be responsible if bid could not be opened online for what so ever reason. However, since the subject package is a SRM Pilot Project of POWERGRID, in the event of any system failures or files corruption and thereby the bid(s) is/are not obtained from the ERP/SRM etendering portal, the Print out of Bids sealed in separate envelope, submitted by the bidder(s) in Envelope-4 and Envelop-5, as hard copy part of the bids shall be opened and referred for comparison/evaluation purpose.

- 9.0 A Single Stage Two Envelope Bidding Procedure will be adopted and will proceed as detailed in the Bidding Documents.
- Bidding Procedure on the portal at or before 15:00 Hrs on As per Rfx. Late bids will not be uploaded and accordingly be rejected. First Envelope i.e. Techno-Commercial Part shall be opened on As per Rfx in the presence of the bidders' representatives who choose to attend in person at the address given below at 15:30 Hrs or may be viewed by the bidders by logging in to the portal as per features available to them. Second Envelope i.e. Price-part shall be opened in the presence of the bidders' representatives who choose to attend at the time and date and at the address given in the intimation for opening of Second Envelope in accordance with Clause 25 of ITB or may be viewed by the bidders by logging in to the portal as per features available to them.

The bid must be accompanied by a bid security of INR 2,29,000/-.
