- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

- 2. **Bidder Turnover:** Documents supporting the Financial Qualification requirem ents attached at Project Experience and Qualifying Criteria Requirement to be u ploaded by the bidder on portal. The complete annual reports together with Aud ited statement of accounts of the company for last five years of its own (separat e) immediately preceding the date of submission of bid to be uploaded.
- 3. Certificate: Bid Forms and Attachments (1st Envelope) attached at "Any other Documents As per Specific Requirement of Buyer -1" need to be filled and uploaded on GeM portal only. Soft copy of the same is attached at Buyer Added Bid Specific ATC document to facilitate bidders. 7. Bidders are requested to quote their lumpsum offer (incl. all taxes) against the custom bid in the financial portion of the bid and the detailed price break- up ag ainst the uploaded BOQ (excel file uploaded) must be uploaded by bidders in the financial portion of the bid only. However, in case price break- up is not submitted by any bidder in the financial portion of the bid, same shall be requested from the L1 bidder only before placement of the award.

Bidders uploading the duly filled BOQ/Price in the technical bid shall be rejected and no further clarification shall be sought.

- 8. **Quantity variation:** Percentage for the quantity variation under this te nder shall be limited to plus/ minus thirty (+/- 30) percent of the total con tract value with individual items to vary up to any extent, during any time of the contract at same rate and terms & conditions. PowerGrid Teleservic es Limited (PowerTel) Amendment to the quantity variation shall be given as per requirement.
- 9. e-RA: e-Reverse Auction shall be conducted as per the provision and Business r ules available in the GeM Portal for e-Reverse Auction.
- 10. MSME criteria: Sellers/ Service Providers claiming to be an MSE have to register on Udyam Registration portal and provide a copy of Udyam Registration certific ate, as documentary evidence in its bid in line with notification of Government of India, Ministry of Small Scale Industries, vide S.O. 1702(E) dated 1 st June, 20 20 superseded by S.O. 2119(E) dated 26/06/2020 published in the Gazette of In dia, Extraordinary, Part II, Section3, Sub-section(ii) and GeM GTC. In case of non-submission of the above mentioned supporting documents, the Seller/ Service Provider shall not be considered as MSE.

Further, all other identifiers for classifying a firm as MSE viz. registration with Di strict Industries Centers (DICs)/ Khadi& Village Industries Commission (KVIC)/ Khadi&Indutries Board (KVIB)/ Coir Board or National Small Industries Corporation (NSIC)/ Directorate of Handicrafts and Handlooms/ Udyog Aadhar Memorandu m etc. may not be accepted for classification as MSE.

If a bidder is MSE (based on the documents submitted in the bid) but has not cla imed for "MSE Purchase Preference" in GeM for the subject tender, MSE purchas e preference shall not be extended for that bidder in that tender.
