### 7. PAYMENT PROCEDURES

#### a) Method of Payment

The Employer shall make payments promptly within thirty (30) days of submission of an invoice/claim by t he Contractor, complete in all respects and supported by the requisite documents and fulfilment of stipulat ed conditions, if any.

All payments to be made directly to the Contractor shall be made by the Employer though electronic pay ment mechanism (e-payment) for which necessary details shall be tied up during execution of the Contract . However, a request for payment to be released through RTGS shall be considered on case-to-case basis and merit of the same.

### b) Bill Tracking System

Prior to submission of bills in physical form, the Contractor shall submit its bills using POWERGRID's Vendo r Bill Tracking System as per procedure detailed herein below. Further, the Contractor may also track the s tatus of its bills using POWERGRID's 'On-line Vendor Bill Tracking System'. To use this system the Contract or is required to get itself registered once online at POWERGRID's ERP Portal with the link URL (https://ete nder.powergrid.in). Once registered, the Contractor may track status of bills submitted, passed and paid by POWERGRID's Corporate Centre and Regional Office(s) under this Contract and other Contracts awarde d on it by POWERTEL by following the method detailed herein below:

- i) Once registered, the Contractor can log-in to POWERGRID's Vendor Bill Tracking System ( BTS) with Vendor Log-In ID and Password.
- After login as at (a) above, Contractor is required to make the entry on POWERGRID's ERP Portal under the tab "Submit New Invoice" and shall fill all details along with the MSE statu s. Upon submission, a 16 digit unique BTS number will be generated and the Contractor will I receive an automated e-mail forwarding the unique BTS number.
- iii) The physical bills alongwith printed copy of e-mail received from BTS (unique BTS numbe r) shall be submitted by the Contractor.
- iv) On receipt of physical bill, concerned POWERTEL's official shall online acknowledge the re ceipt of bill. This action will trigger an automated mail to the Contractor intimating that th e physical copy of the bill has been received and is under verification / processing. Howeve r, on receipt of incomplete bill and/or non-receipt of physical bill by POWERGRID/ POWERT EL official, the incomplete bills/ digital entry in BTS ( as the case may be) shall be returned to the Contractor by POWERTEL, which can be viewed under the tab "Invoice Returned".
- v) The day the payment is made, a mail stating the "Bill number, net payment amount and d etails of the bank from where the payment has been made" will be sent to the Contractor.
- vi) The status of Bill submitted by the Contractor can be checked through the BTS number u nder tab "Invoice Submitted".

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
