GCC SCHEDULE-A15vi) Aa	<p><b>Replace with New Clause</b></p> <p>Percentage for the Change Proposal under this Clause shall be limited to Twenty-Five percent (25%).</p> <p>However, for individual items also, a limit is specified. For items above ground level, the limit for individual items is +25% and for items below ground level, the same is +100%.</p> <p>In case the overall contract price increases by more than 25%, all such items, where executed/anticipated quantity has exceeded/is expected to exceed that specified in the contract by more than 25%, will be identified. In respect of all such items while the quantity originally specified in the contract plus 25% extra shall be paid at unit rates available in the contract, the payment for the balance quantity shall be released at a rate to be decided after negotiation.</p>
