# 3. Quantity Variation:

- a) The contract period shall be for two (2) years.
- b) Quantity Variation of upto +/- 50% over LOA Value, with individual item can vary at any extent depending on the requirement.
- c) The contract period may also be extended/reduced upto maximum of one (0
  1) year using the quantity variation limit (upto -50% or upto +50% over LOA V alue) provided in the contract based on requirement.
- d) The total variation (due to increase in quantity of individual items and/ or incr ease in duration of contract) in contract value shall be limited to the quantity variation limit (upto -50% or upto +50% over LOA Value) provided in the contr act.
- e) PowerGrid Teleservices Limited (PowerTel) Amendment to the quantity variat ion shall be given as per requirement.
- **4. QR:** The Qualifying Requirements like MAAT, past performance criteria of bidders shall be as per PowerGrid Teleservices Limited (PowerTel) QR uploaded as "Qualif ying requirements" in **"Buyer Added Bid Specific SLA".** Bidders shall upload th e documents as proof of compliance to the PowerTel QR.
- **5. e-RA:** e-Reverse Auction shall be conducted as per the provision and Business ru les available in the GeM Portal for e-Reverse Auction
- 6. Liquidated damages Shall be as per GeM
- 7. MSME criteria: Sellers/ Service Providers claiming to be an MSE have to registe r on Udyam Registration portal and provide a copy of Udyam Registration certifica te, as documentary evidence in its bid in line with notification of Government of In dia, Ministry of Small Scale Industries, vide S.O. 1702(E) dated 1 st June, 2020 sup erseded by S.O. 2119(E) dated 26/06/2020 published in the Gazette of India, Extra ordinary, Part II, Section3, Sub-section(ii) and GeM GTC. In case of non-submission of the above mentioned supporting documents, the Seller/ Service Provider shall n ot be considered as MSE.

Further, all other identifiers for classifying a firm as MSE viz. registration with Distr ict Industries Centers (DICs)/ Khadi& Village Industries Commission (KVIC)/ Khadi& Indutries Board (KVIB)/ Coir Board or National Small Industries Corporation (NSIC)/ Directorate of Handicrafts and Handlooms/ Udyog Aadhar Memorandum etc. may not be accepted for classification as MSE.

## If a bidder is MSE (based on the documents submitted in the bid) but has not claimed for "MSE Purchase Preference" in GeM for the subject tende r, MSE purchase preference shall not be extended for that bidder in that tender.

- **8.** Only **Class-I Local suppliers** are eligible to bid. 'Class-I local supplier' means a supplier or service provider, whose goods, services or works offered for procurement, has Local Content equal to or more than 50%. Firms who are not Class-I local supplier shall not be eligible to bid.
- **9. Earnest Money Deposit (EMD):** The Bidder shall furnish, except as exempted herein below, as part of its bid, a bid security in the amount and currency as stipu lated above.

The EMD may be submitted in the following formats,

1. Demand draft with Account Payee Demand Draft in favour of **PowerGrid Teleservices Limited** payable at Gurgaon

2. Bankers Cheque with Banker's Cheque in favour of **PowerGrid Teleservices Limited** p ayable at Gurgaon.

3. Bank Guarantee- Format attached in "Buyer uploaded ATC document". BG shall be valid for 250 days from the original date of bid opening.

Micro and Small Enterprises (MSEs) registered with UDYAM are exempted from submission of Bid Sec urity as per the Provisions of the Public Procurement Policy and GeM GTC. This shall be subject to the production of documentary evidence with regard to registration with authorities mentioned above.

Those MSE Bidder (based on the documents submitted in the bid) who have not claimed f or "EMD exemption" in GeM for the subject tender, EMD exemption benefits shall not be extended for that bidder in the subject tender as per GeM procedures/policies.

#### 10. Security Deposit/Contract Performance Guarantee

- i. The successful bidder is required to submit a Contract Performance Guarantee (CPG) for an amou nt equal to 5% of total Contract value in form of BG. The same shall be extended by the bidder tim e to time till ninety (90) days beyond the actual Defect Liability Period, as may be required under t he Contract. Format attached in "Buyer uploaded ATC document"
- ii. The Bank Guarantee for performance security is to be provided by the Contractor, which should be issued either:
  - a. by a Public Sector Bank located in India or
  - b. a scheduled Indian Bank having paid up capital (net of any accumulated losses) ofRs.1,000 M illion or above (the latest annual report of the Bank should support compliance of capital adeq uacy ratio requirement) or
  - c. by a foreign Bank or a subsidiary of a foreign Bank, acceptable to the Employer, with overall i nternational corporate rating or rating of long term debt not less than A- (A minus) or equivale nt by a reputed rating agency.

Further, the Bank Guarantee should be confirmed by either (i) its corresponding bank located in In dia or (ii) a scheduled commercial private bank located in India as per para (b) above.

The CPG/Security amount will not earn any interest, whatsoever the period retained by PowerTel

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
