1	Could you please clarify whether the bid evaluation criteria will include GST or be considered without GST?	After opening of the financial bid of responsive bidders, bid evaluation shall be done as under: L-1, i.e., lowest bidder(s) shall be established among all the qualified bidders based on least cost / rate of BOQ item "Rate Per month (charges for 3000kms Per month)" including GST indicated in the price schedule of BOQ/Bid Proposal Sheet. Further, L2, L3, L4and so on shall also be identified using the same criteria.
2	Additionally, could you confirm the number of vendors that will be empanelment for this tender?	 For Category -1: Rates for all the individual BOQ items quoted by the lowest bidder(s) in this category i.e. L-1 identified as above shall be offered to L-2, L-3, L-4 and L-5 bidders. If any of L-2, L-3, L-4 & L-5 bidders fail to accept the rate of all the individual BOQ items of this category, then the next bidder in order, i.e., L-6 & L-7 and so on shall be offered to accept the same. First Four (04) agencies accepting all the items rate quoted by L-1 bidder along with L-1 bidder in that category shall be recommended for empanelment in this category. Hence, overall maximum Five (05) agencies shall be empanelled for the subject category. For Category -2, 3 & 4: Rates for all the individual BOQ items quoted by the lowest bidder(s) in
		this category i.e. L-1 identified as above shall be offered to L-2 bidder. If L-2 bidder fails to accept the rate of all the individual BOQ items of this category, then the next bidder in order, i.e., L-3 & L-4 and so on shall be offered to accept the same. Only First agency accepting all the items rate quoted by L-1 bidder along with L-1 bidder in that specific category shall be recommended for empanelment in that category. Hence, overall maximum Two (02) agencies shall be empanelled for these categories.
		In case, none of the agency matches the rate of L-1 bidder, then the empanelment shall be done to L-1 bidder only.
		All decisions made by POWERGRID on the evaluation of bids will be final and binding on the bidders and is not subject to any scrutiny.
3	How many businesses will be distributed to the vendor after the empanelment?	Distribution of work shall preferably be done equally among the empanelled bidder(s) giving preference to the originally identified L1 bidder & then on rotational basis to other bidder(s) as per the requirement.
