1.1 QUALIFICATION CRITERIA

Qualification of bidders will be based on meeting the minimum pass/ fail criteria specified bel ow regarding the Bidder's technical experience and financial position as demonstrated by th e Bidder's responses in the corresponding Bid Schedules. Technical Experience and Financial Position of any proposed subcontractor shall not be taken into account in determining the Bi dder's compliance with the qualifying criteria.

The Owner may assess the capacity and capability of the bidder, to successfully execute the s cope of work covered under the package within stipulated completion period. This assessme nt shall inter-alia include (i) document verification; (ii) bidders work/ facilities visit; (iii) detail s of works executed, works in hand, anticipated in future & the balance capacity available f

or the present scope of work; (iv) details of, manpower and financial resources; (v) details of quality systems in place ; (vi) past experience and performance ; (vii) customer feedback ; (v iii) banker's feedback etc.

The Employer reserves the right to waive off minor deviations if they do not materially aff ect the capability of a bidder to perform the contract.

1.3 FINANCIAL POSITION

(a) Minimum Average Annual Turnover *(MAAT) for the best three (3) years i.e. 36 months out of last five (5) financial years of the bidder should be at least**Rs. 3,13,43,934/-**
