- **A.** Subject tender has been published as 07 different Packages/Schedule as per provision of GeM portal. Eval uation and award of each Package/Schedule shall be done separately as per provision of GeM portal.
- **B.** Package wise **Technical Specification** is attached in buyer uploaded ATC document. Same shall prevail in case of any contradiction with TS uploaded at item level in BOQ based GeM bid.
- C. BOQ for the each of the Package/Schedule is attached in the GeM bid in ATC (in pdf format) and under "Pr ice Schedule" in excel format for reference.
- D. Bidders have to quote the lumpsum price inclusive of GST for each Package/Schedule based on the provided BOQ of respective packages. Bidders have to quote prices only on GeM portal.

Bidder shall not upload any attachment of price, or its breakup under technical part of their bid in GeM portal.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
