- 2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidd subject to acceptance of L1 bid price.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. - 3. **Bidders are requested to quote their Total price (Including GST) in the P ce bid on GeM portal**. All other terms and conditions as per existing Dark Fiber I asing Agreement with POWERGRID/ POWERTEL shall remain unchanged for subject ease case, even in the event of expiry of Dark fiber leasing Agreement during the urrency of PO/ contract.
- 4. Non-Empanelment parties shall be considered non-responsive. Non-empaneled, be does are requested to directly contact this office for empanelment to participate if future Tenders.
- 5. During execution, POWERGRID shall check the length of fiber using OTDR and cal ulate the total price as below:

Calculated Price (INR) = [Length of Fiber as per OTDR reading] x [Unit rate o Fiber (UF/ OH) as per existing agreement] x [Duration in Year]

- 6. Further, the payment will be processed as below:
  - i) If 'Calculated Price' is lesser than price quoted by bidder in GeM, maximum payment to party will be limited to 'Calculated Price'.
  - ii) If 'Calculated Price' is greater than price quoted by bidder in GeM, LOA p ce shall prevail and maximum payment will be done as price quoted in GeM
- 7. Bidder has to upload existing agreement with POWERGRID / Standard lease fiber greement uploaded in SLA of this Bid.

## a) Method of Payment

The Employer shall make payments promptly within thirty (30) days of submission of an invoice/claim by the Contractor, complete in all respects and supported by the requisite documents and fulfilment of stipulated conditions, if any.

All payments to be made directly to the Contractor shall be made by the Employer hough electronic payment mechanism (e-payment) for which necessary details shall be tied up during execution of the Contract. However, a request for payment o be released through RTGS shall be considered on case-to-case basis and merit o the same.

## b) Bill Tracking System

Prior to submission of bills in physical form, the Contractor shall submit its bills usi g POWERGRID's Vendor Bill Tracking System as per procedure detailed herein below. Further, the Contractor may also track the status of its bills using POWERGRID's On-line Vendor Bill Tracking System'. To use this system the Contractor is required to get itself registered once online at POWERGRID's ERP Portal with the link URL (<a href="https://etender.powergrid.in">https://etender.powergrid.in</a>). Once registered, the Contractor may track status obills submitted, passed and paid by POWERGRID's Corporate Centre and Regional ffice(s) under this Contract and other Contracts awarded on it by POWERTEL by fol owing the method detailed herein below:

- i) Once registered, the Contractor can log-in to POWERGRID's Vendor I II Tracking System (BTS) with Vendor Log-In ID and Password.
- ii) After login as at (a) above, Contractor is required to make the entry n POWERGRID's ERP Portal under the tab "Submit New Invoice" and shall fill all details along with the MSE status. Upon submission, a 16 digit nique BTS number will be generated and the Contractor will receive an automated e-mail forwarding the unique BTS number.
- iii) The physical bills alongwith printed copy of e-mail received from BTS (unique BTS number) shall be submitted by the Contractor.
- on receipt of physical bill, concerned POWERTEL's official shall online acknowledge the receipt of bill. This action will trigger an automated neal to the Contractor intimating that the physical copy of the bill has been received and is under verification / processing. However, on receipt incomplete bill and/or non-receipt of physical bill by POWERGRID/ POWERTEL official, the incomplete bills/ digital entry in BTS (as the case mate) shall be returned to the Contractor by POWERTEL, which can be viewed under the tab "Invoice Returned".
- v) The day the payment is made, a mail stating the "Bill number, net p yment amount and details of the bank from where the payment has be n made" will be sent to the Contractor.
- vi) The status of Bill submitted by the Contractor can be checked througe the BTS number under tab "Invoice Submitted".

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / ac / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Paymer of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Paymen of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may tak suitable actions as per GeM Contract.
