- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of

quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The Bidder must have successfully executed the Supply of T&P and/ or electrical equipment during last Seven (07) years as on last date of bid submission (Soft copy) per following:

One Single Contract of value not less that INR 1,68,360.

OR

Two Contracts each of value not less than INR 1,05,225

OR

Three Contracts each of value not less than INR 84,180

- 2. **Payment Terms**: Hundred Percent (100%) of the Contract price s hall be paid on Successful delivery of equipment and Taking Over by the Employer and on submission of documents indicated herein under:;
 - a) Evidence of receipt of material at site (Receipted L/R)
 - b) Receipted Delivery Challan, packing list etc
 - c) GST Invoice
 - d) Guarantee Certificate or Manufacturer's/Contractor's guarantee c ertificate of Quality
 - e) Material Receipt Certificate /Evidence of receipt of material / M aterial Acceptance Certificate/ taking over Certificate issued by the Purchaser's representative.
 - f) Factories/Manufacturer's Test / Inspection certificates of Supplier (if applicable)
 - g) Invoice should be raised in the name of Consignee
 - h) GEM CRAC

The Employer shall make payments promptly within thirty (30) days of submission of an invoice/claim by the Contractor, complete in all respects and supported by the requisite documents and fulfillment of stipulated conditions, if any. All invoices/claims shall be raised by t

he Contractors in the name of POWERGRID. All the payment shall be released to the Contractor from PPPFC (POWERGRID Payment Proce ssing & Facilitation Center), Bengaluru.

All payments to be made directly to the Contractor shall be made by the Employer though electronic payment mechanism (e-payment) for which necessary details shall be tied up during execution of the Contract.

Statutory tax/levies as applicable at the time of payment shall be de ducted at source unless concerned tax authorities exempt the contr actor. POWERGRID shall affect TDS as per the rules/statutory requir ements and issue TDS certificates. Part shipment and transhipment is not permitted.

Payments shall be released by POWERGRID Payment Processing and Facilitation Center (PPPFC), Bangalore.

Payment Tracking - The Contractor/Seller may track the status of its bills using POWERGRID's 'On-line Vendor Bill Tracking System'. To u se this system, the Contractor is required to get itself registered onc **ERP** online at POWRGRID's Portal with the link (https://etender.powergrid.in). Once registered, the Contractor/ Seller may track status of bills submitted, passed and paid by POWE RGRID's Corporate Centre and Regional Office under this Contract a nd other Contracts awarded on it by POWERGRID by following the m ethod detailed herein below:

- a) Once registered, the Contractor/ Seller can log-in to POWERGRI D's Vendor Bill Tracking System with Vendor Log-In ID and Passwor d.
- b) Bill entry is to be done by the Contractor/ Seller on POWERGRID's ERP Portal prior to submission of bill. An automated e-mail with uniq ue reference number will be sent to the Contractor/ Service Provider , which needs to be printed and attached on top of the correspondin g physical bill to be submitted by the Contractor/ Seller to POWERG RID.
- c) On receipt of physical bill, concerned POWERGRID's official shall o nline acknowledge the receipt of bill. This action will trigger an auto mated mail to the Contractor/ Seller intimating that the physical cop y of the bill has been received and is under verification / processing.
- d) The day the payment is made, a mail stating the "Bill number, net payment amount and details of the bank from where the payment has been made" will be sent to the Contractor/ Service Provider.

3. DURATION OF CONTRACT

The completion Schedule shall be 90 days from the date of GeM Contract.

4. **Warranty**: The Equipment/materials must carry Warranty against defective material, poor workmanship & unsatisfactory performance etc

. 12 Months from the date of commissioning or 18 Months from the date of dispatch, whichever is earlier against any manufacturing defects, from the date of receipt of material in good conditions at site.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
