

Bid Corrigendum

Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

1. Buyer Added text based ATC clauses

1. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.
2. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

3. To be eligible for participation, following qualifying criteria shall be applicable:

i) As per statutory compliance Bidder must have valid Unified License with valid NLD authorization issued from Department of Telecommunication (DOT), Govt of India for providing NLD/MPLS service as on the originally scheduled date of Bid Opening" i.e. 03.11.2025

ii) The bidder must have successfully executed# the following similar* work during last seven (07) years, as on the originally scheduled date of Bid Opening mentioned above:

One single contract of value not less than Rs. 2.12 Lacs (Excl. GST).

(or)

Two contracts each of value not less than Rs. 1.325 Lacs (Excl. GST).

(or)

Three contracts each of value not less than Rs. 1.06 Lacs (Excl. GST).

*Similar work means: Providing P2P lease bandwidth (NLD/MPLS) in any PSU / Govt. / Private Organization)

#Successful execution means: Successful completion of work as on the originally scheduled date of Bid Opening mentioned above. Bidder shall submit user certificate for the completion/performance of the work without any adverse remarks.

4. Documents in support of qualifying criteria mentioned above to be uploaded by the bidder on portal.

Note: During evaluation of bids, if it is found that bidder(s) has not submitted related document(s) pertaining to work orders/performance certificates etc. submitted with the bid to demonstrate the compliance to qualifying criteria above, PowerTel reserves the right to obtain such document(s) from the bidder or through its own sources or from its other records and the same may be considered for evaluation. In respect of the submission of incomplete documents in bid with regard to qualifying criteria, only related shortfall documents shall be asked for and considered. For example, if the bidder has submitted a work order

r without its completion/performance certificate, the certificate can be asked for and considered. However, no new work order shall be accepted to qualify the bidder.

5. Other terms and conditions shall be as per Detailed Scope of Service and Buyer uploaded ATC document.

6. Corrigendum-I to bid document dated 17.11.2025 is attached at Buyer uploaded ATC document. All bidders are requested to go through all the documents, including the amendment, prior to submission of bid.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
