# **13. Assignment Clause:**

Notwithstanding anything to the contrary contained in this tender/agreement, POWE RGRID may assign, novate or transfer its rights and obligations under this tender/Agr eement to its 100% wholly owned subsidiary, namely POWERGRID TELESERVICES LIM ITED.

# Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
