Qualification of the Bidder will be based on meeting the minimum pass/fail criteria specified below regarding the Bidder's technical experience and financial position as demonstrated by the Bidder's responses in the corresponding Bid Schedules.

Technical experience and financial resources of any proposed subcontractor shall not be taken into account in determining the Bidder's compliance with the qualifying criteria.

The employer may assess the capacity and capability of the bidder to successfully execute the scope of work covered under the package within stipulated completion period. This assessment shall inter-alia include (i) do cument verification; (ii) details of works executed, works in hand, anticipated in future & the balance capacity available for the present scope of work; (iii) past experience and performance; (iv) customer feedback; (v) Banker's feedback; etc.

The contractor has to provide documentary evidence in support of the experience, such as an Execution ce rtificate along with LOA & BOQ from any utility that similar equipment has been supplied, installed and comm issioned or the party maintained the system described in 1.a for at least one year as on originally scheduled date of Bid opening. 1.0 **SCOPE OF WORK**

- 1.1 The detailed scope of work covered under the package is specified in the Maintenance Philosophy, Technical Specifications and is indicated briefly hereunder:
- 1.2 The scope of work covered under the package includes AMC, the contractor shall have prime respons ibility to maintain the Fibre Optic Communication System Equipment and associated Network Management S ystem (NMS) so as to ensure maximum availability of the equipment.

The Scope of work will include the maintenance of the Wide band Communication System equipment in the Southern Region 2.

All the referred equipment installed in Southern region 2 of India is under the scope of the maintena nce. However, integration with other regions such as NR, NER, SR region for Pan-India ULDC network is also cover under present maintenance.

All the equipment and NMS related hardware and software, supplied under "Establishment of Fibre Optic Communication System In lieu of Existing ULDC Microwave links in Southern Region and Communication equipment package under establishment of fibre optic communication system for centra I sector stations of southern region and other standalone equipment supplied under various Substation Packages", networking of NMS including cabling, etc. for NMS system shall also be covered.

The scope of AMC also covers repair of faulty cards without any additional costs.

- 1.3 AMC covered for all the component within the existing equipment/BOQ items & for cards/components added within the AMC covered equipment during the AMC period. The Primary Multiplexer & Add drop Multiplexer are to be considered as a Primary Multiplexer in the BOQ items.
- 1.4 Details of equipment/cards proposed under AMC Package is enclosed at **Annexure-A** and Fibre Optic Communication System (FOCS) network map is enclosed at **Annexure-B** (attached at ATC Document)
- 1.5 **Repair of faulty Cards: -** The scope of AMC also covers repair of faulty cards and the no separate repair charges will be paid to contractor.
- 1.6 The spares shall be and any item other than, as specified in TS, required for FOCS Maintenance /repair shall be arranged by the contractor at his own cost.
- 1.7 If the cards/equipment are burned out/physically damaged due to external fire hazard, lighting, n atural calamities etc. and beyond repair, the same are not to be covered in the scope of contracto r.

The scope of AMC excludes breakdown maintenance of OPGW (Optical Ground Wire), UGFO cable, Approach cable, distant user fiber cable, FODP, etc.

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws /

acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
