Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

1. Buyer Added text based ATC clauses

1. Quantity Variation & Extension Of Time Period:

- a. The contract period shall be for three (3) years.
- b. Quantity Variation of upto -30% or upto +50% over LOA Value, with individual item can vary at any extent depending on site condition and requirements.
- c. The contract period may also be extended/ reduced upto maximum of one (01) year using t he quantity variation limit (upto -30% or upto +50% over LOA Value) provided in the contract based on requirement.
- d. The total variation (due to increase in quantity of individual items and/ or increase in duratio n of contract) in contract value shall be limited to the quantity variation limit (upto -30% or u pto +50% over LOA Value) provided in the contract.

POWERGRID Amendment to the quantity variation shall be given as per requirement

- 2. QR: The Qualifying Requirements like MAAT, past performance criteria of bidders shall be as per POWERGRID QR uploaded in "Pre Qualification Criteria (PQC) and Project Experience and Qualifying Criteria Requirement". Bidders shall upload the documents as proof of compliance to the POWERGRID QR.
- **3. e-RA:** e-Reverse Auction is not applicable for the subject tender.
- **4. MSME criteria:** Sellers/ Service Providers claiming to be an MSE have to registe r on Udyam Registration portal and provide a copy of Udyam Registration certifica te, as documentary evidence in its bid in line with notification of Government of In dia, Ministry of Small Scale Industries, vide S.O. 1702(E) dated 1 st June, 2020 sup erseded by S.O. 2119(E) dated 26/06/2020 published in the Gazette of India, Extra ordinary, Part II, Section3, Sub-section(ii) and GeM GTC. In case of non-submission of the above mentioned supporting documents, the Seller/ Service Provider shall n ot be considered as MSE.

Further, all other identifiers for classifying a firm as MSE viz. registration with District Industries Centers (DICs)/ Khadi& Village Industries Commission (KVIC)/ Khadi& Industries Board (KVIB)/ Coir Board or National Small Industries Corporation (NSIC)/ Directorate of Handicrafts and Handlooms/ Udyog Aadhar Memorandum etc. may not be accepted for classification as MSE.

If a bidder is MSE (based on the documents submitted in the bid) but has not claimed for "MSE Purchase Preference" in GeM for the subject tende

r, MSE purchase preference shall not be extended for that bidder in that tender.

5. Earnest Money Deposit (EMD): The Bidder shall furnish, except as exempted herein below, as part of its bid, a bid security in the amount and currency as stipu lated above.

The EMD may be submitted in the following formats,

Micro and Small Enterprises (MSEs) registered with UDYAM are exempted from submission of Bid Sec urity as per the Provisions of the Public Procurement Policy and GeM GTC. This shall be subject to the production of documentary evidence with regard to registration with the authorities mentioned abov

Those MSE Bidder (based on the documents submitted in the bid) who have not claimed f or "EMD exemption" in GeM for the subject tender, EMD exemption benefits shall not be extended for that bidder in the subject tender as per GeM procedures/policies.

6. Security Deposit/Contract Performance Guarantee

- i. The successful bidder is required to submit a Contract Performance Guarantee (CPG) for an amou nt equal to 10% of total Contract value in form of BG. The same shall be extended by the bidder ti me to time till ninety (90) days beyond the actual Defect Liability Period, as may be required under the Contract. Format attached in "Buyer uploaded ATC document."
- ii. The Bank Guarantee for performance security is to be provided by the Contractor, which should be

issued either:

- a. by a Public Sector Bank located in India or
- b. a scheduled Indian Bank having paid up capital (net of any accumulated losses) ofRs.1,000 mi llion or above (the latest annual report of the Bank should support compliance of capital adeq uacy ratio requirement) or
- c. by a foreign Bank or a subsidiary of a foreign Bank, acceptable to the Employer, with overall i nternational corporate rating or rating of long term debt not less than A- (A minus) or equivale nt by a reputed rating agency.

Further, the Bank Guarantee should be confirmed by either (i) its corresponding bank located in In dia or (ii) a scheduled commercial private bank located in India as per para (b) above.

The CPG/Security amount will not earn any interest, whatsoever the period retained by POWERGRI D.

 - i. Supporting documents (POs and performance certificate) for compliance of technical experience as per POWERGRID Qualifying requirements (QR).
 - j. Power of Attorney
 - k. Company details (Registration certificate, GST registration certificate, PAN, bank details with pro of, profile of the company, MSME if applicable, PF details etc.,)

The above list is exhaustive; however bidders are requested to go through the bid document and submit the requisite documents

12. In case of any contradiction in terms and conditions between the GeM Policy a nd POWERGRID Bidding Document, the latter shall prevail.

13. Assignment Clause:

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
