## **Bid Corrigendum**

## GEM/2025/B/5778908-C1

Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

## **Buyer Added Bid Specific Additional Terms and Conditions**

- 1. Buyer Added text based ATC clauses
  - 1. Evaluation of bids shall be carried out based on TPIA (Third Party Inspection Agency) verified document s submitted with the bid. Bids submitted without TPIA's verified/certified documents specific to the tendered package shall not be considered for evaluation and the bid shall be summarily rejected.

Certification from TPI Agencies who are under suspension by NABCB/Holiday list or not having valid accreditation from NABCB, shall not be considered during tender/bid evaluation.

FORMAT FOR CERTIFICATION BY TPIA TO BE PROVIDED BY BIDDER ON THEIR LETTER-HEAD attached as Bi dding Form No. 1 of Buyer uploaded ATC document.

- 2. (i) A Price Breakup sheet (in excel) has been attached to the Price Schedule in the bid.
- (ii) Estimated cost including Overhead charges (@6.5% of prevailing minimum wages) (except Contractor 's profit and applicable GST) has been indicated in the price schedules. The Overhead Charges caters to t he expenses to be incurred by the Contractor towards procuring labour license, compliance of PF & ESI, o perational cost of contract including bank charges towards CPG, cost of manpower replacement as and w hen required, interest on the amount deducted from the running bills towards TDS, Security Deposit etc. a nd Cost of coordination / management of the labour engaged in the Contract etc.
- (iii) Bidders are required to fill the profit (excluding GST) as % (percentage) of the base price in the attached Price Breakup and quote the final amount (Incl. GST) in GeM portal, which shall be fixed for entire duration of Contract. Bidders shall have to upload the dully-filled Price Breakup in pdf format under "Financial Document Indicating Price Break Up" on GeM Portal only. Bidders shall not upload the Price Breakup in Technical part of the Bid in soft copy and shall not submit any Price component in Hard copy of the bid, otherwise their bid shall be rejected, and no further clarification shall be sought.
- (iv) The above rate (%) of Overhead Charges and profit margin shall remain fixed for entire duration of Co ntract and shall be paid on prevailing minimum wages.
- (v)This bid has been created with floor price (minimum value) which is indicated in the price schedule. Bid ders are advised not to quote below the floor price (minimum value). Bid below the floor price (minimum value) shall be rejected.
- 3. Amendment/Substitution/Addition to GTC, Qualifying Requirements, certain forms to be uploaded while Bid Submission and other documents are attached at Buyer uploaded ATC document.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to

such representations.
