#### 2.0 Maintenance & Service Details:

- 2.i. The scope of work includes comprehensive AMC of 24 nos. of different brand and different type of air c onditioner located at various locations in North Bengal as per the details given above.
- 2.ii. During AMC the service provider (SP) shall carry out 4 nos. visit (service provider shall carry out 02 no. wet and 02 no. dry services for total 04 visit) in a year, each visit in a quarter. During AMC the SP shall also carry out one number of preventive maintenance (overhauling) services per year.
- 2.iii. The service provider shall attend unlimited nos. of breakdown maintenance even in weekday off or Ho liday.
- 2.iv. Any component (Compressor, Condenser coil, PCB board, Display Unit) supply and replacement of an y brand and type of AC shall be under the scope of service provider, no separate payment shall be made t owards their repair and replacement. This also includes Gas charging/filling and transportation of all materials, tools & tackles as per requirement of Site.
- 2.v. Supply of Copper pipe, nitrile insulation, Drain pipe, outdoor stand, power cable, AC installation & unin stallation (related to shifting work) shall not be in scope of the service provider.
- 2.vi. No work except break down maintenance will be undertaken on closed holidays and beyond office ho urs on any day except by prior approval / direction of the Buyer.

Price Variation: The Contract price shall remain FIRM and FIXED and shall not be subject to Price adjustmen t for the entire duration of the Contract.

Save above, all other terms and conditions shall be as per GeM special terms and conditions (STC) for ann ual maintenance contract- AMC service of air conditioner.

### 3.0 Payment Terms:

The payment will be made to AMC Service provider on quarterly basis on submission of bill by the vendor on completion of each quarter after deducting penalty amount if applicable.

- 5.0 Bidder shall submit compliance to the "Specific Scope" attached.
- 6.0 Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is I ower), subject to the maximum of quoted GST %.
- 7.0 Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.
