1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating

Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY.The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

QUALIFYING REQUIREMENT OF BIDDER: QUALIFYING REQUIREMENTS FOR BIDDERS

Supply and installation of Portacabin for Site office at Gadag, K oppal and Bidar

1. General

1.1. Qualification of bidder will be based on meeting the minimum pass/fail criteria specified below regarding the Bidder's technical experience and financial position as demonstrated by the Bidder's responses in the document submitted during bidding.

1.2. POWERGRID reserves the right to waive off minor deviations to QR, provided it does not impact the execution of contract. The decision of POWERGRID in this regard shall be final & binding on bidders.

1.3. POWERGRID reserves the right to assess the capacity and capability of the bidder, should the circumstances warrant such assessments in an overall interest of the owner.

2. Technical Requirement

The Bidder should have successfully executed Any Building work in India directly to any State / Central Govt. Departments or State/Central Government Undertakings, during the last 7 years from the originally scheduled date of bid opening with minimum value as follows:

(i) Three similar completed works of value not less than the amount equal to Rs. 38.95(Excluding GST) Lakhs each.

OR

(ii) Two similar completed works of value not less than the amount equal to Rs 48.68 (Excluding GST) Lakhs each.

OR

(iii) One similar completed work of value not less than the amount equal to Rs 77.89 (Excluding GST) Lakh.

2.1. Documents to be submitted as evidence of above:

A) A copy of Performance Report from the Client, Completion Certificate from the Client indicating amount and year of completion or Any documentary evidence in support of having completed the requisite work(s) as per the requirement like acceptance of final bill by client etc.

3. Financial Requirement

3.1 The Minimum Average Annual Turnover (MAAT)* of the bidder for the best three financial years out of the last five financial years immediately preceding the financial year of originally scheduled date of bidding (FY 2022-23, 2021-22, 2020-21, 2019-20 & 2018-19) shall be minimum of Rs 97.36 LAKHS.

Note: * For the purpose of arriving at MAAT, Annual total income as incorporated in the profit & loss account excluding non-recurring income, e.g. Sale of fixed assets shall be considered.

RELAXATION FOR MSME BIDDERS MSMEs :

All MSE bidders are exempted from meeting MAAT requirement..

- MSE as defined in the bidding documents. Bidder shall furnish documentary evidence in support of the qualifying requirements stipulated above.

Documents to be submitted as evidence of above:

Audited balance sheet and Profit & Loss Account for the preceding five financial years. In case, the audited balance sheet for latest financial year is not available, a certificate from the Chartered Accountant on their letter head certifying the financial turnover for the latest financial year may be submitted.

In case bidder is a holding company, the financial requirement criteria referred above shall be of that holding company only (i.e. excluding its subsidiary/ group companies). In case bidder is a subsidiary of a holding company, the financial requirement criteria referred above shall be of that subsidiary company only (i.e. excluding its holding company).

The Following points may also be noted by the bidders

(a) Purchase preference and EMD exemptions to Micro and Small Enterprises (MSEs): Purchase preference and EMD exemptions will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference and EMD exemptions, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.

(b) Further, In case a MSE bidder who has submitted a valid MSE document in their bid but has not opted for MSE status while submitting their bid on GEM. In such cases the bidder shall be considered as non-MSE and shall not be eligible for MSE purchase preference. In case such bidder is L-1, they will be considered as Non-MSE and other MSE bidders shall be given option for purchase preference as per GEM procedures / policies.

(C) Earnest Money Deposit: The Bidder shall furnish, except as exempted, as part of its bid, a bid security in the amount and currency as stipulated in the Bid document. The EMD may be submitted in the following formats,

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer

is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
