Accordingly, bidders with Local Content less than or equal to 20% will be treated as "Non Local Supplier". The prescribed LC shall be applicable on the date of Bid opening. Sanctions on the bidders for false / wrong declaration or not fulfilling the Local Content requirement shall be as per the PPLC policy. - ii. Along with Each Invoice: The local content certificate (issued by statutory auditor on behalf of procuring company) shall be submitted along with each invoice raised. - 18. Pre-dispatch inspection at Seller premises (Fee/Charges to be borne by the BUYER): Before dispatch, the goods will be inspected by Buyer / Consignee or their Authorized Representative or by Nominated External Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at Seller premises (or at designated place for inspection as declared / communicated by the seller) for their compliance to the contract specifications. Fee/Charges taken by the External inspection Agency and any external laboratories testing charges shall be borne by the Buyer. For in-house testing, the Sellers will provide necessary facilities free of cost. Seller shall notify the Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the goods' shipment. While bidding, the sellers should take into account 7 days for inspection from the date of email offering the goods for inspection. Any delay in inspection beyond 7 days shall be on the part of the buyer and shall be regularised without Liquidated Damages.
 - When there is requirement of submission the advance sample, the seller shall inform the buyer promptly through emails about the date of submission of sample to the buyer nominated Inspection agency.
- 19. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
- 20. The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.
- 21. Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.
- 22. Buyback for Non PFMS/Non GPA:
 - 1. GST will apply on the value of buyback and separate invoice is to be prepared by Government buyer/Consignee for buyback items offline outside the GeM system. Vendor should work out input credit for that GST applicable on the buy back while quoting the product/services.
 - 2. Input GST Credit consideration by seller- seller shall offer the prices in the bid by the total amount of new goods including GST- total amount of old goods quoted by the firm excluding GST. This is because GST charged by buyer on buy-back value will be available for full ITC (input tax credit) on the hands of bidder. Seller after the award of the GeM contract, will indicate all column A to G which will not alter their quoted price indicated in Colum-G

- 3. Successful lowest bidder has to provide detailed cost break up of tendered items as well as buy back items separately after award of contract through email to the government buyer/consignee.
- 4. The seller of new item /service provider shall deposit the cost of invoiced buy back item with GST to the buyer for allowing seller to lift up the material from the buyer/consignee premise.
- 5. Transportation of buy back items from buyer premises shall be arranged by the seller itself without any extra cost.
- 6. Government Buyer organisation /consignee will issue invoice of buy back items to the seller at the cost of buyback to be indicated to the buyer by the seller offline after receipt of order. This in no case will modify the bid in any manner.
- 7. The seller will be entirely responsible for the safe disposal of old items without affecting the environment in any manner as per prevailing statutory rules and Act/ law of the land.

All terms and Conditions of the Tender shall be governed by WPPP of POWERGRID , same be referred from the link : https://www.powergridindia.com/wppp. The provisions of the Bidding Documents shall always prevail over that of 'Works and Procurement Policy and Procedures' (WPPP) document in case of contradiction.

OTHER TERMS AND CONDITIONS.

<u>Installation</u>

The Contractor shall be responsible for complete installation of all the battery banks supplied as per the Specification including Unpacking, installation, removal of shipping brackets, mounting and connection, powering up, verification of proper battery operation, and all other recommended start-up procedures required to be performed. The Contractor shall extend all necessary assistance for integration of Battery Bank with DCPS/IPMS being procured under separate package. All required installation labour shall be supplied by the Contractor. Employer's personnel will be available, during the installation and start-up period for any support, if required.

Materials Handling and Storage Requirements

All the equipment furnished under the contract and arriving at site shall be promptly received, unloaded and transported and stored in the store by the Contractor. The Contractor shall be responsible for examining each shipment and shall notify Employer immediately of any damage, shortage, discrepancy, etc. for the purpose of Employer's information only. However, the Contractor shall be solely responsible for any shortages or damages in transit, handling and/or in storage and erection of the equipment at site.

Technical Support

Technical support shall be provided by the Contractor through final acceptance of the facilities by POWERGRID. This support shall be available on-site, when deemed necessary by POWERGRID. The Contractor remains solely responsible for correction of variances and warranty problems

Maintenance

The minimum one-year period commencing immediately after the operational acceptance(SAT) is called the defect liability period. It shall be the responsibility of the Contractor to maintain and repair/replace all the supplied Battery banks including Battery cells/modules and other accessories etc. till the completion of defect liability period without any extra financial implication

Buyback of old battery

The Contractor shall also completely dismantle the presently installed battery bank along with all power cables and associated items as and where directed by the Employer as per the approved BOQ uploaded under ATC document. The battery bank along with all associated hardware except power cables shall be bought back by the Contractor as directed by the POWERGRID. Scope of work shall include for batteries under buyback loading, unloading, transportation or any other

documentation associated with it. The contractor shall remove old and dismantled battery within 45 days after successful installation and commissioning of new battery at site. After lapse of 45

days POWERGRID shall not have any responsibilities whatsoever against the dismantled batteries under buyback.

The bidder/seller shall upload undertaking in technical attachments for supply, installation, testing and commissioning of VRLA battery banks including buyback of old battery banks as per Technical Specification with BoQ uploaded under "Buyer added Bid Specific Additional Scope of Work" and the BoQ uploaded under ATC document for technical qualification of bid.

Quantity Variation:

Percentage for the Change Proposal under this Clause shall be limited to plus/ minus thirty (+/-30) percent of the total contract value indicated in Price Schedule during any time of the contract at same rate and terms & conditions with implementation schedule of one year. The individual items may vary to any extent depending on the actual site conditions & execution for the subject package.
