1. Buyer Added Bid Specific ATC

1. Evaluation of bids (for QR compliance) shall be carried out based on TPIA verified documents submitted with the bid. Bids submitted without TPIA's verified/certified documents specific to the tendered package shall not be considered for evaluation and the bid shall be summarily rejected.

<u>Certification of Documents by NABCB accredited TPIA (Third Part Inspection Agency)</u>

TPIA means— A third party inspection agency which is registered under "NABCB accredited bodies as per requirement of ISO/IEC17020 as Type A" in QCI's NABCB website (https://nabcb.qci.org.in).

The verification and certification should necessarily include the name and contact details (contact number and e-mail ID) of the certifying officer, TPIA name with the address of TPIA branch undertaking the certification.

Document Verification/Certification:

- a. Bidder shall submit the certificate from TPIA along with the bid for the tendered package, as per the Format enclosed at Bidding Form-1 of ATC.
- b. All charges/Fee for the services rendered by Third party Inspection agency (TPIA) shall be borne by the Bidders. The submission of authentic documents is the prime responsibility of the Bidder. However, PowerTel reserves the right to get the document cross verified at its own discretion.

Certification from TPI Agencies who are under suspension by NABCB/Holiday list or not having valid accreditation from NABCB, shall not be considered during tender/ bid evaluation.

The Employer shall be the sole judge in this regard and the Employer's interpretation of the Shortlisting shall be final and binding.

2. Quantity Variation: Percentage for the quantity variation under this tender shal I be limited to plus/minus fifty (+/- 50) percent of the total contract value with i ndividual items to vary up to any extent, during any time of the contract at same r ate and terms & conditions. POWERGRID Teleservices Limited (PowerTel) Amendm ent to the quantity variation shall be given as per requirement.

3. Price Bid:

- (a) Bidders are requested to quote the price in GeM portal itself. The bid price shall include all the co sts for the entire scope of work incl. GST as per the Bidding Documents. The Bid Prices quoted by the bidde rs cover all the Contractor's obligations mentioned in or to be reasonably inferred from the Bidding Docum ents to successfully execute the intended services, on a "Single Responsibility" basis. Bidders are required to quote the price for the commercial, contractual and technical obligations outlined in the Bidding Docum ents including Scope of Work.
- (b) A Price Breakup sheet (in excel) has been attached to the Price Schedule in the bid. Estimated cost includi ng Overhead charges (@6.5% of minimum wages) (except Contractor's profit and applicable GST) has been indicated in the price schedules. The Overhead Charges caters to the expenses to be incurred by the Contractor towards procuring labour license, compliance of PF & ESI, operational cost of contract including bank charges towards CPG, cost of manpower replacement as and when required, interest on the amount deducted from the running bills towards TDS, Security Deposit etc. and Cost of coordination / management of the labour engaged in the Contract etc. The above rate of Overhead Charges shall be fixed for entire duration of Contract. 6.5% of overhead charges shall be paid on prevailing minimum wages.
- (c) Bidders are required to fill the Contractors profit (in Rs. excluding GST) or profit (excluding GST) as % (percentage) of the base price in the attached Price Breakup and quote the final amount (Incl. GST) in GeM portal, which shall be fixed for entire duration of Contract. Contractor profit margin shall be paid on prevailing minimum wages. - (e) In addition to the above, the premium charges of Mediclaim Insurance policy will be reimbursable (Maximum 3.25% of wages) on submission of original receipt for those employees who do not fall under ESI Policy. No additional payment would be paid against this policy.

- **8.** Only **Class-I Local Suppliers** are eligible to bid. 'Class-I local supplier' means a supplier or service p rovider, whose goods, services or works offered for procurement, has Local Content equal to **100%.** Fi rms who are not Class-I local supplier shall not be eligible to bid.
- **9.** Earnest Money Deposit (EMD): The Bidder shall furnish, except as exempted herein below#, as part of its bid, a bid security in the amount and currency as stipulated below*.
