Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. 7. During bid evaluation, the Employer may, at its discretion, ask the Bidder for a clarification of its bid. In case of erroneous/non submission of documents, i.e., documents* related to documents submitted in supp ort of Qualifying Requirements or the complete annual reports together with Audited statement of account s, Online Payment acknowledgement towards Bid Security (in cases where online payment has been made prior to the deadline for submission of hard copy part of the bids) or documentary evidence with regard to registration with designated Authority of GoI under the Public Procurement Policy for MSEs or documentary evidence with regard to MSE owned by SC/ST entrepreneurs or women in line with Public Procurement Policy for MSEs, Self certification regarding Minimum Local Content, Integrity Pact and Safety Pact, required to be submitted by the Bidder as per the provisions of the Bidding Documents, the Employer may give the Bidder not more than 4 working days' notice to rectify/furnish such documents, failing which the bid shall be rejected.
