4. Power of Attorney, Safety Pact, Integrity Pact, Bid Security Declaration (Attachment-25), Attachment-21 and Attachment 22 need to be uploaded on portal and hard copy to be submitted to the office.
5. "Undertaking for Hardcopy Submission" attached in "Any Other document specific to Buyer-2" need to be filled and uploaded if bidders couldn't courier the hard copy of required documents.
