2. Bid Forms and Attachments (Bid Form for First Envelope or Bid Form and First Envelope) attached at "Buyer uploaded ATC document " need to be filled and uploaded on GeM portal only. Soft copy of the same is attached at Bu yer uploaded ATC document to facilitate bidders. - 7. Payment Terms: Payment Shall be in Quarterly Arrears with terms as per Technical Specification attached as Detailed Scope of Service
- 8. MSME criteria: Sellers/ Service Providers claiming to be an MSE have to registe r on Udyam Registration portal and provide a copy of Udyam Registration certificate, as documentary evidence in its bid in line with notification of Government of India, Ministry of Small Scale Industries, vide S.O. 1702(E) dated 1 st June, 20 20 superseded by S.O. 2119(E) dated 26/06/2020 published in the Gazette of In dia, Extraordinary, Part II, Section3, Sub-section(ii) and GeM GTC. In case of non-submission of the above-mentioned supporting documents, the Seller/ Service Provider shall not be considered as MSE.

- 9. Only Class-I Local suppliers are eligible to bid. 'Class-I local supplier' means a supplier or service provider, whose goods, services or works offered for procure ment, has Local Content equal to or more than 50%. Firms who are not Class-I local supplier shall not be eligible to bid.
- 10. Supplier shall ensure that the Invoice is raised in the name of Consignee with G STIN of Consignee only.
- 11. **Bid Validity:** Bids shall be valid for a period of 180 days from the date of open ing of Technical bids. The above Bid validity period shall supersede any other cl ause in GeM Bid. All bidders shall comply the same in their bid and accept the bid validity extension in GeM portal, whenever requested by the buyer.
