





### **Bid Corrigendum**

#### GEM/2023/B/4238037-C1

Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

### **Buyer Added Bid Specific Additional Terms and Conditions**

- 1. Buyer Added text based ATC clauses
- 1. **Experience Criteria:** Documents in support of technical Qualification require ments attached at Project Experience and Qualifying Criteria Requirement to be uploaded by the bidder on portal.
- 2. **Bidder Turnover:** Documents supporting the Financial Qualification require ments attached at Project Experience and Qualifying Criteria Requirement to be uploaded by the bidder on portal. The complete annual reports together with A udited statement of accounts of the company for last five years of its own (sepa rate) immediately preceding the date of submission of bid to be uploaded.
- 3. Certificate: Bid Forms and Attachments (1<sup>st</sup> Envelope) attached at "Any other Documents As per Specific Requirement of Buyer -1" need to be filled an d uploaded on GeM portal only. Soft copy of the same is attached at Buyer Add ed Bid Specific ATC document to facilitate bidders. In case of non-submission of bid form & attachments in the portal (soft copy part of the bid) within the stipulated deadline, then even if the bidder has submitted the specific documents in hard copy part in original within the stipulated deadline pursuant to ITB 17.1, its bid shall be considered as incomplete bid, which shall be summarily rejected. For simplicity the excel copy of the bid form can be downloaded from CPPP Portal for subject tender. However, any discrepancies in the bid form submitted may lead to rejection.
- 4. **Additional Doc 1:** Documents requested at ITB 15.4 shall be scanned & uplo aded on the portal.
- 5. **Additional Doc 2:** Bid Security, Power of Attorney, Integrity Pact, Safety Pact, Bid Security, Attachement-20, Attachment-21, Attachment-25 & Attachment-2 6 need to upload on portal and Original hard copy of same to be submitted to the address:

# 6. Additional Doc 3 & 4: Any other documents by bidders

7. Bidders are requested to quote their lumpsum offer (incl. all taxes) against the custom bid in the financial portion of the bid and the detailed price break- up a gainst the uploaded BOQ (excel file uploaded) must be uploaded by bidders in the financial portion of the bid only. However, in case price break- up is not sub mitted by any bidder in the financial portion of the bid, same shall be requested from the L1 bidder only before placement of the award.

Bidders uploading the duly filled BOQ/Price in the technical bid shall be rejected and no further clarification shall be sought.

- 8. **Quantity variation:** Percentage for the quantity variation under this t ender shall be limited to plus/ minus thirty (+/- 30) percent of the total co ntract value with individual items to vary up to any extent, during any tim e of the contract at same rate and terms & conditions. PowerGrid Teleser vices Limited (PowerTel) Amendment to the quantity variation shall be gi ven as per requirement.
- 9. MSME criteria: Sellers/ Service Providers claiming to be an MSE have to registe r on Udyam Registration portal and provide a copy of Udyam Registration certificate, as documentary evidence in its bid in line with notification of Government of India, Ministry of Small Scale Industries, vide S.O. 1702(E) dated 1 st June, 2020 superseded by S.O. 2119(E) dated 26/06/2020 published in the Gazette of India, Extraordinary, Part II, Section3, Sub-section(ii) and GeM GTC. In case of non-submission of the above mentioned supporting documents, the Seller/ Service Provider shall not be considered as MSE.

Further, all other identifiers for classifying a firm as MSE viz. registration with District Industries Centers (DICs)/ Khadi& Village Industries Commission (KVIC)/ Khadi&Indutries Board (KVIB)/ Coir Board or National Small Industries Corporati on (NSIC)/ Directorate of Handicrafts and Handlooms/ Udyog Aadhar Memorand um etc. may not be accepted for classification as MSE.

If a bidder is MSE (based on the documents submitted in the bid) but has not cl aimed for "MSE Purchase Preference" in GeM for the subject tender, MSE purch ase preference shall not be extended for that bidder in that tender.

10. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

  - c. Integrity Pact (attachment-14 in first envelop and bid forms)
  - d. Safety Pact (attachment-18 in first envelop and bid forms)
  - e. Certificate from bank as per attachment-16 in first envelop and bid for ms. (Format given in 'Payment terms, insurance and sample forms' in pa yment Terms) " need to be filled and uploaded.
  - f. Local Content Declaration: Bidders shall submit Self certification regard ing Local Content in line with PPP-MII order and DoT Order, on a non-judicial stamp paper of Rs. 100/-. (Format given in Attachment-21 of first en velop and bid forms).
  - g. Audited Balance sheets of last 5 financial years.
  - h. Supporting documents (POs and performance certificate) for complianc e of technical experience as per PowerTel Qualifying requirements (QR).
  - i. Power of Attorney
  - Company details (Registration certificate, GST registration certificate, P AN, bank details with proof, profile of the company, MSME if applicable, P F details etc.,)

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
