1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

3. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Buyer Added Bid Specific ATC

1. Terms and conditions mentioned in Buyer Added Bid Specific ATC and provisions mentioned herein below, will supersede the GeM GTC and the provisions mentioned above.
2. Consignees mentioned above are indicative only. Actual Consignee details shall be shared with successful bidder(s) during project execution.
3. Local Content of 60% for Class-I Local Supplier indicated in bid against each of the BOQ item is for the entire package and not for the respective individual item. Presently, the local content requirement to categorize a supplier as Class-I Local Supplier is minimum 60%. Firms who are not Class-I Local Supplier shall not be eligible to bid.
4. Delivery Period mentioned above against each of the BOQ item is total Contract duration for the subject package. Delivery period requirement shall be in line with the Buyer Added Bid Specific ATC.
5. The requirement of Bid Security/EMD shall be governed as per the provisions of Buyer Added Bid Specific ATC, which shall supersede the provisions indicated above related to EMD.
6. The Primary product appearing above is just indicative. The relevant provisions regarding the same shall be governed as per Buyer Added Bid Specific ATC.
7. Document required from seller shall be governed as per the Buyer Added Bid Specific ATC.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization.
