- 1.0 This invitation for bids follows the e-procurement notice (Invitation for Bids) for the subject package published on 04.07.2024 on POWERGRID's website and e-procurement portal given at para **5.0** below and on Government of India's Central Public Procurement Portal (<u>https://eprocure.gov.in</u>). Any Corrigendum and/or amendments, etc shall also be published only on the above website/portals.
- 2.0 Power Grid Corporation of India Ltd. (A Government of India Enterprise) incorporated under the Companies Act, 1956, having its Registered Office at B-9, Qutab Institutional Area, Katwaria Sarai, New Delhi-110016 (hereinafter referred to as POWERGRID'/'Owner') has decided to invite bids for "Painting of External Wall of Valve Hall/Service Building at ±800 KV HVDC Converter Station, Alipurduar."
- 2.1 The work activities in respect of the aforesaid Project shall be carried out by the Owner himself and it intends to use domestic funding for eligible payments under the contract for the package as mentioned above. For the purpose of all procurement activities, the Owner shall also be referred to as 'Employer'.
- 3.0 POWERGRID, therefore, invites bids from eligible bidders for the following package under secured e-procurement procedure as per the details below:

(\*)Micro and Small Enterprises (MSEs) registered with Udyam Registration Portal specified by Ministry of Micro, Small and Medium Enterprises are exempted from submission of fee towards the cost of Bidding Documents as per the Provisions of the Public Procurement Policy for Micro and Small Enterprises (MSEs) order 2012, Notification dated 01/06/2020 and 26/06/2020 read in conjunction with related notifications issued from time to time for such enterprises. Further, EMD exemption and purchase preference benefits shall not be extended to such MSE bidders who are Traders.

#### 3.0.1 FIRMS WHO ARE NOT CLASS-I LOCAL SUPPLIERS SHALL NOT BE ELIGIBLE TO BID.

This is in line with Public Procurement Policy – Make In India (PPP-MII) order 2017 and its revision dtd 16.11.2021. Local suppliers have to submit self-certification on their company's letter head regarding Minimum Local Content in line with PPP-MII order 2017 and its revision dtd 16.11.2021 as per format at Attachment-21 of "First Envelope and Bid Forms", Vol.-I of Bidding Documents. Refer Annexure-B(Purchase Preference Policy), Vol-I of Bidding Documents for description of Class 1/Class 2 Local Suppliers.

This Invitation for Bids extended through media, website or written communication or by any other means, and issuance of Bidding Documents as per para 7.0 below shall not be construed to mean that the prospective bidders to whom the Invitation for Bids has been extended and /or Bidding Documents have been issued is deemed eligible bidder. The eligibility of the bidders shall be determined as per the provisions of Bidding Documents.

3.1 The scope of work covered under this Package includes **Painting of External Wall of Valve Hall /Service Building at ± 800 KV HVDC Converter Station, Alipurduar**" as detailed in Bidding Documents.

The above scope of work is indicative and the detailed scope of work is given in the Scope of Work, Technical Specification (Volume-II) of the Bidding documents.

- 3.2 The Completion Period for the entire scope of work which includes "**Painting of External Wall of Valve Hall/Service Building at ± 800 KV HVDC Converter Station, Alipurduar**" shall be the period as specified in ITB.
- 3.3 Bidding will be conducted through the domestic competitive bidding procedures as per the provisions of ITB/BDS and the contract shall be executed as per the provisions of the Contract. Bidders may note that the Employer has uploaded its 'Works and Procurement Policy and Procedures' (WPPP) document along with its Modification/Amendment on "Capacity and Capability Assessment- regarding new parties undertaking erection works of Transmission Line Tower package" and on "Ineligibility of Firms for Participation in the Bidding Processs" and on "Black-Listing of Firms / Banning of Business" and its updation on





POWERGRID's website referred to at para 5.0 below. It shall be noted that no other party, including the Bidder/Contractor, shall derive any right from this 'Works and Procurement Policy and Procedures' (WPPP) document or have any claim on the Employer on the basis of the same. The respective rights of the Employer and the Bidder/Contractor shall be governed by the Bidding Documents/Contract signed between the Employer and the Contractor for the respective packages. The provisions of the Bidding Documents shall always prevail over that of 'Works and Procurement Policy and Procedures' (WPPP) document in case of contradiction.

- 4.0 The detailed Qualifying Requirement (QR) are mentioned in the bidding documents.
- 5.0 The complete Bidding Documents are available at POWERGRID's website http://www.powergrid.in as well as on portal https://etender.powergrid.in (hereinafter referred to as the 'portal'). Interested bidders can download the bidding documents and commence preparation of bids to gain time. However, in case of any discrepancy in the document the same downloaded from the latter shall prevail.
- 6.0 **Interested bidders have to necessarily register themselves on the portal** <u>https://etender.powergrid.in</u> to participate in the bidding under this invitation for bids. It shall be the sole responsibility of the interested bidders to get themselves registered at the aforesaid portal for which they are required to contact at the following Phone number or address given at Para 10.0 to complete the registration formalities:

- 6.1 The said registration shall be free of cost. On completion of registration process, the registering bidders will be provided with User ID and Log-In password.
- 6.2 Bidders are requested to read the 'PRANIT-Bidders Manual and Pre-Requisite Document' available on e-Tender web link <u>https://etender.powergrid.in</u> before proceeding for submission of bids. It is important to note that bidders can submit their bids online only through <u>https://etender.powergrid.in</u>.
- 6.3 In order to upload the documents that to submit the bids electronically, Bidder's power of authority holder who is authorized to submit the offer & sign contract must have a valid Class 3 Digital Certificate (signing and encryption / decryption certificate).
- 6.4 For proper uploading of the bids on the portal, it shall be the sole responsibility of the bidders to apprise themselves adequately regarding all the relevant procedures and provisions as detailed at the portal.
- 6.5 They may obtain further information regarding this tender from the Office of Sr DGM(CS), POWERGRID Kolkata at the address given at para 10.0 below from 10:00 hours to 17:30 hours on all working days till the sale of Bidding Documents is open.
- 6.6 For proper uploading of the bids on the portal, it shall be the sole responsibility of the bidders to apprise themselves adequately regarding all the relevant procedures and





provisions as detailed at the portal for the same directly from ERP PRANIT Help Desk or Office of Sr DGM(CS), POWERGRID Kolkata at the address given at para 10.0 as and when required. The Employer in no case shall be responsible for any issues related to timely or properly uploading/submission of the bid in accordance with the relevant provisions of the Section II – ITB of the Bidding Documents.

7.0 Bidders can download the bidding documents from the portal without registering or paying document fees in advance, any time from **14:00 hrs on 04.07.2024**, however, interested bidders have to pay document fees for participation in the tendering and submission of the bid. For this purpose the interested bidders shall be required to pay **INR 5,000/-** as non-refundable document fees *in the form of e-Payment, On Line Payment on POPU (POWERGRID Online Payment Utility, please refer ITB Cl. 13.2 for details)* or furnish the details of exemption from payment of document fees including applicable documentary proof on all working days up to **03.08.2024**, 17:00 hrs. Any bid not accompanied by an acceptable fees towards cost of bidding document shall be rejected by the employer as being non responsive, pursuant to ITB Sub-Clause 22.1.

The bidding documents are meant for the exclusive purpose specifically for the work of "Painting of External Wall of Valve Hall/Service Building at ± 800 KV HVDC Converter Station, Alipurduar" and shall not be transferred to any other party or reproduced or used otherwise for any purpose other than for which they are specifically issued.

- 8.0 A single stage two envelope bidding procedure will be adopted and will proceed as detailed in the Bidding Documents.
- 8.1 Soft Copy part of the bids must be uploaded under Single Stage Two Envelope Bidding Procedure on portal on or before **11:00 hrs on 05.08.2024**. The e-Procurement system would not allow any late submission of bids through the portal after due date and time as specified.

Hard Copy part of the Bids must be submitted under Single Stage Two Envelope Bidding Procedure at the address given below at or before **11:00 hrs on 05.08.2024**. In case Hard Copy part of the Bid is not received by the Employer till the deadline for submission of the same prescribed by the Employer, but the bidder has uploaded the soft copy part of the bid, the soft copy part of the first envelope bid uploaded on the portal shall be opened. Such bids will be rejected during preliminary examination.

First Envelope i.e. Techno-Commercial Part shall be opened on the same day i.e. **05.08.2024** in the presence of the bidders's representative who choose to attend in person at the address given below at **11:30** hours or may be viewed by the bidders by logging in to the portal as per features available to them. Second envelope i.e. Price Part shall be opened in the presence of Bidder's representatives who choose to attend at the time and date and the address given in the intimation for opening of Second Envelope in accordance with Clause 25 of ITB or may be viewed by the bidders by logging in to them.

8.1.2 Bid security of **INR 3,70,000/-** for Package must be submitted in the physical form of receipt from POPU or Bank Guarantee or exemption certificate at the address given at para 10.0 below at or before 11:00 hrs on **05.08.2024**. POWERGRID shall not be responsible for any postal delay in respect of submission of hard copy part of this bid.

#### 8.2 Bid shall be uploaded on portal as per IFB.





However, only EMD, Integrity Pact, Safety pact, Power of Attorney, document pertaining to <u>local content etc.</u>, which are part of hard copy part of the bid shall be submitted as hard **copy** part of bids.

- 8.3 The Employer reserves the right to conduct e-Reverse Auction (e-RA) for packages above Rs. 2 Crore in accordance with ITB Cl. 29. However, **E-RA is not applicable** for this package.
- 9.0 POWERGRID reserves the right to cancel/withdraw this invitation for bids without assigning any reason and shall bear no liability whatsoever consequent upon such a decision.
