If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. Schedule-1,2,3: Only Underground optical fiber is required for links in Schedule-1, Schedule-2 and Schedule-3.

Empaneled parties without any existing UG rate agreement with M/s PowerTel/M/s POWERGRID can also participate in the subject tender by quoting UG fibre length with unit rate per pair per km per annum in "Price_Schedule".

1. Bidder has to upload copy of existing Dark Fiber leasing Agreement with POWERGRID/PowerTel in their Technical Bid on GeM portal.
2. Route diagram and License Agreement should be uploaded in Technical Bid on GeM portal
3. Following instructions to be followed while filling Price_Schedule:
 - a) Bidders Details, Address & Contact details are required to be filled properly.
 - b) Rate (in Rs. per Km per year per pair) must be filled same as per Dark Fiber leasing Agreement with POWERGRID/PowerTel. The awarded rate per pair per km per annum for fiber leasing shall be considered for entire Contract/PO duration.
