

ON-BOARDING OF MICRO, SMALL AND MEDIUM ENTERPRISES (MSMES) ON  
TRADE RECEIVABLES DISCOUNTING SYSTEM (TReDS) PLATFORM

- As per Gazette of India (extra-ordinary) notification of 2<sup>nd</sup> November 2018, all Central Public Sector Enterprises shall be required to get themselves on the Trade Receivables Discounting System (TReDS) platform.
- POWERGRID has already been registered on all the Four (4) nos. of Trade Receivables Discounting System (TReDS) platforms of (i) Receivable Exchange of India Limited (RXIL) (A NSE - SIDBI JV), (ii) Mynd Solutions Private Ltd (M1xchange), (iii) A TREDS Ltd. (Invoicemart) and (iv) C2FO Factoring Solutions Private Limited (C2treds) in order to facilitate financing of Trade receivables of MSMEs and compliance with the aforesaid notification.
- Ministry of Micro, Small and Medium Enterprises (MoMSME), subsequently has also directed all CPSEs to get onboard their MSMEs Vendors on the TReDS Platform.
- All the Micro, Small and Medium Enterprises (MSMEs), who are vendors of POWERGRID, are therefore advised to get themselves registered on TReDS Platforms of RXIL, M1xchange, Invoicemart and C2TReDS.
