

Invitation to Micro and Small Enterprises (MSEs) in the business of products/services required for 33 kV and above Voltage Transmission Systems for their participation in 'Regional Vendor Development Program cum Industrial Exhibition for MSEs' being organized by POWERGRID

1. Power Grid Corporation of India Ltd. (POWERGRID) is a "Navaratna" Central Public Sector Enterprise. It is a Central Transmission Utility (CTU) of India and is the largest Electric Power Transmission Utility of India. It is a listed Company since 2007. POWERGRID is consistently rated "Excellent" under Memorandum of Understanding with Ministry of Power since 1993-94. POWERGRID owns and operates about 1,48,754 ckt. kms of transmission lines at 800/765kV, 400kV, 220kV & 132kV EHVAC & ± 500 kV HVDC levels and 237 sub-stations. This gigantic transmission network, spread over length and breadth of the country, carries about half of the total power in the country and is consistently maintained at an availability of over 99%. In addition to transmission business, POWERGRID is also in the telecom business and it owns & operates about 47,735 km of telecom network with point of presence in 688 locations and intra city network in 105 cities across India. The backbone telecom network availability is more than 99.5%. Based on its vast experience and expertise, POWERGRID has also provided/ is providing transmission related consultancy to more than 150 domestic clients as well as to more than 25 foreign clients spread across in 20 countries (*information as on 24.08.2018*). 2. POWERGRID is mainly in the business of construction and operation of 33 kV and above Voltage Transmission Systems.

In an endeavor to enhance participation of MSEs in its project procurement as per the Public Procurement Policy for Micro and Small Enterprises Order 2012 issued by Ministry of Micro, Small & Medium Enterprises (Ministry of MSME), POWERGRID, in consultation with Development Institute (DI) - MSME, Okhla, New Delhi, intends to organize a National Vendor Development Program cum Industrial Exhibition for MSEs who are in the business of products/services required for 33 kV and above Voltage Transmission Systems. Interested MSEs, who are not associated with POWERGRID as its vendors/ sub-vendors & are not included in its „Compendium of Vendors“ as on date and are in the business of products/services required for 33 kV and above Voltage Transmission Systems, may make request for participation & furnishing requisite particulars alongwith supporting documentary evidences, for which the deadline is upto 17.00 hrs. (IST) on 14.01.2018. Late request; or request for participation with incomplete particulars; or request for participation with complete particulars however not supported with requisite supporting documentary evidences will not be considered for which POWERGRID shall be sole judge.

As per the „Compendium of Vendors“ of POWERGRID, as on date various MSEs are associated with POWERGRID as its vendors/ sub-vendors and these MSEs are manufacturers of components/ inputs namely angles, conductor, cable, tank for transformers, bolts & nuts, clamp & connectors, hardware fittings, instrument transformer, energy meters, isolator, PLCC, copper conductor for transformer etc.

MSEs, who are interested to participate in the National Vendor Development Program cum Industrial Exhibition for MSEs being organized by POWERGRID, are required to fill-up the excel format which can be downloaded from the links (i) “04.2_MSE_details_vdp2018_DMS” (*for products/ services for voltage level from 33kV to 132 kV, also referred to as ‘DMS’ category*); (ii) “04.3_MSE_details_vdp2018_PG” (*for products/ services for voltage level above 132 kV, also referred to as ‘PG’ category*); (iii) “04.4_Credential Documents” (*for various credentials of the MSE pertaining to their factory, their products, their quality process, their customers, their experience etc.*).

In case an interested MSE is desirous to participate in both DMS as well as PG categories, it shall must submit separate excel formats and credential documents alongwith all supporting documentary evidences for (i) DMS category &

(ii) PG category. Late request; or request for participation with incomplete particulars; or request for participation with complete particulars however not supported with requisite supporting documentary evidences will not be considered for which POWERGRID shall be sole judge.

After the deadline, requests, complete in all respects, will be examined by POWERGRID for finalization/short-listing of MSEs (as required depending upon the response/ nature of business of MSEs etc. for which POWERGRID will be sole judge). The finalized list shall be published latest by **19.01.2019** on „MSE National Vendor Development Program cum Industrial Exhibition-2018“ in „Tender“ Section of POWERGRID“s website – www.powergridindia.com.
8. The details of MSE vendor-wise schedule for presentation, stall number for industrial exhibition for their products etc. (as opted) etc. shall also be made available on „MSE National Vendor Development Program cum Industrial Exhibition-2018“ in „Tender“ Section of POWERGRID“s website – www.powergridindia.com.
9. The inclusion of MSEs in „Compendium of Vendors“ of POWERGRID shall be as per POWERGRID“s policy and procedure in vogue, for which POWERGRID shall be sole judge.

Vendors/MSEs may kindly note that the sole purpose of this exercise is organizing National Vendor Development Program cum Industrial Exhibition for MSEs as well as analysis of credentials of suitable MSEs for their inclusion in „Compendium of Vendors“ of POWERGRID as per POWERGRID“s policy and procedure in vogue. However, this exercise shall not confer any right to any vendor. In this regard, no vendor shall have any claim on POWERGRID on the basis of the same for what-so-ever reasons.
