This has reference to your letter dated 5<sup>th</sup> September, 2013 seeking information under RTI Act, 2005.



Dear Sir,

This has reference to your RTI application dated 29/08/2013 received in Power Grid from Ministry of Power, New Delhi vide which you have sought information under Right to Information Act-2005. Now we have received your letter dt.24.01.2014 vide which you have referred the references of the letter of MOP and CPIO, Power Grid. In your letter you have also made allegation that CPIO, Power Grid/NR-I has not supplied the desired information in accordance with the RTI Act- 2005 and penalty of Rs.25000/- may be imposed as per the provision of RTI Act for not adhering the guidelines of the Act regarding supplying of information.

In this reference, it is to intimate that your RTI Application was received in the office of the undersigned on 04/10/2013 vide letter No. 13/101 dt.01/10/2013 of CPIO, Power Grid, CC, Gurgaon and only after a lapse of 14 days vide letter No.NR1/Ballia/S/S/RTI/644 dt.18.10.2013 (copy enclosed) of Shri P.K.Mahalik who is Chief Manager in Power Grid Ballia Office has been provided you the information. In his letter Shri P.K.Mahalik clearly mentioned that there is no High Voltage Transmission Line constructed or under construction by Power Grid Corporation of India Ltd. from Ballia to Selempur, Deoria to Delhi. The High Voltage Transmission Line under question may be pertaining to M/s UPPCL (Govt. Of UP). So the question of violation of the guidelines of RTI Act not arises. This is for favour of information and further necessary approach with UPPCL for seeking your desired information.
