ORDER


The appellant Shri Shailendra Kumar Singh, ERS, PW-II, 07 BRD, AF, Air Force Station, Tughlakabad, New Delhi-110062 vide his application Dt.08/07/2013 had requested for providing certain information in respect of his Complaint Letter Dt.08/04/2013 addressed to The Power Minister, Shram Shakti Bhawan, Rafi Marg, New Delhi-110001 copied to Chief Vigilance Officer, Power Grid, NR-I regarding "**No Action Against Aman Kumar Singh by Power Grid Corporation of India Ltd. NR-I**" under the Provisions of Right to Information Act, 2005 from CPIO, Power Grid NR-I, Katwaria Sarai, New Delhi. The point-wise information desired by the applicant in the above RTI applications has already been provided to the appellant vide letter No.Power Grid/NR-I/RTI/469/4284 dtd.02.08.2013 after obtaining the information from HR and Vigilance Department of Power Grid, RHQ, NR-I.

Now the 1st Appeal u/s 19(1) of the RTI Act, 2005 dated 18/10/2013 made by the applicant before the First Appellate Authority, POWERGRID, NR-1. In his appeal the appellant Shri Shailendra Kumar Singh mentioned that he has not been provided the satisfactory information vide letter No.Power Grid/NR-I/RTI/469/4284 dtd.02.08.2013. On receipt of the above appeal dt.18.10.2013 through Executive Director (NR-I) the First Appellate Authority, CPIO NR-I, Shri T.C.Sarmah has again been requested to Vigilance Department/NR-I for providing/furnishing the satisfactory information as desired by the appellant to point No.2 (i), (ii) & (iii) vide IOM No.NR-I/PESM/RTI-Appeal/471/7015 dt.30.10.2013. In response to the appeal of the Appellant Vigilance Department of Northern Region-I has again been reiterated which was earlier informed to the appellant vide letter No.Power Grid/NR-I/RTI/469/4284 dtd.02.08.2013 the complaint has been verified by the Vigilance Department of NR-I and Verification Report to Corporate Vigilance Department on 31.01.2013 and subsequently the Corporate Vigilance Department has forwarded the Verification Report to Corporate HR Department on 02.05.2013 (Copy of IOM No.NR-I/Vig./RTI/2013/292 dt.07.11.2013 of Shri G.C.Maithani, Manager(Vigilance), NR-I enclosed).

On going through the contents of the appeal, facts and sequences briefed and shown by the CPIO, NR-I, Shri T.C.Sarmah it is found that the information which is given to him by the respective departments has immediately been forwarded to the applicant.

Now, therefore, on going through the above discussion, processing/efforts made by CPIO/NR-I it is concluded that on verification, the said case has forwarded by the Vigilance Department of NR-I to Corporate HR Department through Corporate Vigilance Department, therefore, CPIO, NR-I is directed that the said Appeal dt.18.10.2013 of Shri Shailendra Kumar Singh may be forwarded/transferred to First Appellate Authority/CPIO, Corporate Centre for information and directly providing the information to the appellant so that the appeal can be disposed off accordingly.
