वर्धा ते औरंगाबाद या दरम्यान ४०० किलोवॉट क्षमतेची नवी वीज वाहिनी लवकरच टाकण्यात येईल, अशी माहिती पॉवर ग्रीड कॉर्पोरेशन ऑफ इंडियाचे अध्यक्ष आर. एन. नायक यांनी दिली. क्रॉप्टन ग्रीडजने उभारलेल्या रिसर्च सेंटरच्या उद्घाटनप्रसंगी ते बोलत होते. देशात सध्या दोन लाख तीस हजार मेगावॉट विजेची निर्मिती होते. मागणीच्या तुलनेत ही निर्मिती अत्यल्प आहे. त्यामुळे येत्या काळात मोठ्या प्रमाणात वीजनिर्मितीचे लक्ष्य मारताने ठेवले आहे. तसेच, निर्माण झालेल्या विजेचे योग्य वहन होणेही आवश्यक आहे. यासाठीच वर्धा ते औरंगाबाद या दरम्यान तिनशे किलोमीटर लांबीची ८०० केव्हीची वीज वाहिनी टाकण्याचे काम लवकरच सुरू होणार असल्याचे नायक यांनी मावेली सांगितले.

वेस्ट लँडचा सहारा

बालवंट, लडाख, हिमाचल प्रदेशातील काही भाग अशा प्रकारची देशात २.१५ लाख हेक्टर जमीन वेस्ट लँड आहे. या जमिनीचा वापर सौर ऊर्जेच्या निर्मितीसाठी करता येऊ शकतो. यातील अवघ्या दोन टक्के जागेचा वापर केला तरी १००० मेगावॉट विजेची निर्मिती होऊ शकेल, असे नायक यांनी स्पष्ट केले.
