I, Karuna Kanta Pattnaik S/O Late Chandra Dhawaja Pattnaik, Vill. Satiguda(Talaguda) PO : Panchabati PS/Dist. Malkangiri is a bonafide citizen of India and belongs to Below Poverty Line (attested copy of B.P.L card enclosed herewith)

The village Himansupalli of Sindrial G.P under Malkangiri Block (Malkangiri District, Odisha State) is a single Revenue Village. There is no hamlet village of said Himansupalli village. The said village has been electrified under RGGVY Scheme during 2011-2012. In this village 20 to 30 BPL house holders are already been enjoying electricity since last one year and above whereas at about 50 to 60 BPL families were deprived off to get electricity till date for which they have filed complaint cases before the Dist Consumer Forum on such discrimination. In the above premises I need the following information from the General Manager, Power Grid Corporation of India Limited (Agoverment of India Enterprises under the Ministry of Power), Regd. Office : B/9, Quatab Institutional Area, Katwaria Sarai, New Delhi-110 016 under the provisions of R. T.I Act., 2005.

1. Please specify the reasons for such discrimination and the name of the Officer & officials responsible for such discrimination.
2. Copies of all communications made between the PGCIL and Jyoti Infrastructures Ltd on the progress of work of electrification in the said Village.
3. Copies of all communication made between the authorities of PGCIL with the office of the Rural Electrification & SOUTH Co or any other concerned for charging of power supply to BPL house holders after completion of electrification work.
4. When the discriminated BPL house holder will avail the electricity (please specify the date)
5. Copies of file noting on movement of this RTI application
6. Any other related information.
