1-4) Assessment is carried out as per the provision's of the Tender Document as indicated below:


In line with Clause No 23.0 of section-II Vol.I i.e Instruction to Bidders," Purchaser will ascertain to its satisfaction whether Bidders determined having submitted substantially responsive bids are qualified, as per the Qualification Requirement specified in Annexure-A (BDS) to satisfactorily perform the contract. The Purchaser shall be the sole judge in this regard and the Purchaser's interpretation of the Qualification Requirement shall be final and binding.

The determination will take into account the Bidder's financial, technical capabilities including production capabilities, in particular the Bidder's contract work in hand, future commitments and current litigation and pas performance. It will be based upon an examination of the documentary evidence of the Bidder's qualifications submitted by the Bidder in Attachment 3 to the bid, as well as such other information as the Purchasers deems necessary and appropriate. This shall, however, be subject to assessment that may be carried out, if required by the Purchaser as per the provisions of Annexure-A (BDS). The Purchaser shall be the sole judge in this regard".

5) The information sought can not be disclosed as per the Clause 29.1 (Confidentiality and Contacting the purchaser) & Clause 32.2 (Notification of Award) of Section-II of Vol-I i.e Instruction to Bidders.
