3. The I.O. In-charge himself is authorized and competent to scrutinize the inspection reports and is accountable for the same.
4. The inspection reports for the year 2012-13 for suppliers of Ludhiana are available in our Chandigarh office. We have 10 Sub-Vendors of Bolt-Nut manufacturing in Ludhiana. All procurement from these vendors is through our main Transmission Line/Sub-station Contractors and sharing of reports with any third party would amount to encroachment into business privacy of Main Contractors/sub-vendors/various manufacturers and is against business ethics. However, if consent from above agencies is obtained in this case, we may be able to show the requested documents.
