This has reference to your letter dated nil (received on 27th December, 2013) seeking information under RTI Act, 2005.

The information sought is given below:

- 1) Details of seats reserved for Physically Handicap (PH), OBC & OBC-PH is given below:

Category	No of seats reserved in Gate 2014(current vacancy)
PH	4
OBC	29
OBC-PH	Reservation for PH being horizontal, no reservation is separately kept for OBC-PH. The candidate can belong to any category.

- 2) POWERGRID has started adopting GATE results for selection of candidates in Electrical Engineering from 2012 onwards. Accordingly, the information pertaining to All India Recruitment from GATE in EE discipline is as under:

- 3) (i) Recruitment has not been carried out in POWERGRID in any Group-A post which is non-identified for persons with disabilities. In case of Group-B, C & D posts, DoPT guidelines for computing 3% reservation on total number of vacancies in the cadre strength is already being followed. Hence, no fresh vacancy will be created.

(ii) The concept of backlog has been defined by DoPT's OM no. 36035/10/2006-Estt(Res)Desk dated 12.12.2006. The same is being taken into account for calculation of the backlog.
