The plot no 244 (Survey No 56/1) in Gouthami Nagar phase —I which is mentioned in the RTI application is located in Sriperumbudur Village, Kanchipuram District. The said location is falling in the route of 400 KV Vallur — Kalivanthapattu D/C line, which is commissioned already and power flow of about 400MW is taking place to cater to the city of Chennai and its adjoining areas.

In this regard, it is to inform that all the activities related to construction of 400kV Vallur-Kalivanthapattu D/C line have been carried out, complying with all statutory requirements under Section 10 of the Indian Telegraphic Act, 1885, Section 164 of the Electricity Act, 2003 and GOI order dated 24.12.2003 vide gazette of India No 1148, which authorize POWERGRID to exercise all powers vested in Telegraph Authority under part III of the Indian Telegraphic Act 1885 in respect of Electrical Lines and Electrical plants established or maintained or to be so established or maintained for transmission of electricity or for the purpose of telephonic or telegraphic communication necessary for the proper coordination of works. As per the provisions of the act, POWERGRID shall not acquire any property under, over, along, across, in or upon which the transmission lines have to be placed and hence no compensation is paid. However for the damaged crops/trees, if any, the compensation as assessed by the State Government Authorities will be paid by POWERGRID.
